## RESOLUTION APPROVING ZONING PETITION

BOOSE, III, TRUSTEE, for a SPECIAL EXCEPTION TO ALLOW THE EXCAVATION AND REMOVAL OF MUCK, SAND, ROCK, SHELL, SOIL OR OTHER EXTRACTIVE MATERIALS on the West 1/2 of the Northwest 1/4 of Section 36, Township 40 South, Range 37 East, containing 80.64 acres, more or less, together with that certain rightof-way easement in the North 20 feet of the East 3896.52 feet of the South 1/2 of Fractional Section 35, Township 40 South, Range 37 East, as recorded in Official Record Book 1583, page 147, subject to a right of ingress and egress to the above described right-of-way easement to the East 1/2 of the Northwest 1/4 of Section 36, Township 40 South, Range 37 East.
