

RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 77-44 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 28 April 1977

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session this 28th day of April, 1977, that petition No. 77-44 the petition of PALM BEACH COUNTY UTILITIES COMPANY, by Ted Climer, Vice President for a SPECIAL EXCEPTION TO ALLOW RAW WATER PLANT PUMPING FACILITY on a parcel of land lying in the Southwest 1/4 of Section 35, Township 41 South, Range 42 East, being more particularly described as follows: Beginning at the Northwest corner of said Southwest 1/4 of said Section 35; thence Easterly along the North line of said Southwest 1/4, a distance of 466.69 feet; thence along a line parallel with the West line of said Section 35, a distance of 466.77 feet; thence Westerly along a line parallel to said North line of the Southwest 1/4 of Section 35, a distance of 466.69 feet to the said West line of Section 35; thence Northerly along said West Section line, a distance of 466.77 feet to the POINT OF BEGINNING; subject to rights-of-way, easement and/or reservation of records, if any; together with the right of ingress and egress over the North 25 feet of the South 1/2

of said Section 35. Said property located on the east side of Sunshine State Parkway approximately .2 mile south of Hood Road in an AG-Agricultural District, was approved as advertised.

Commissioner Evatt , moved for approval of the petition. The motion was seconded by Commissioner Medlen , and upon being put to a vote, the vote was as follows:

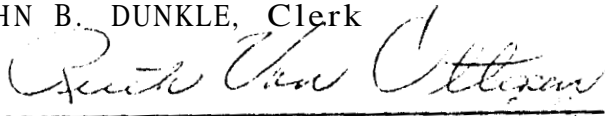

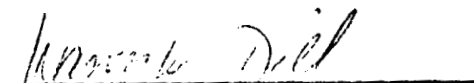
