

RESOLUTION NO. R-78-70

RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 77-191 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 29 December 1977.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session the 29th day of January, 1977, that petition No. 77-191 the petition of MRS. JAMES J. (JESLYN C.) CORBETT, JAMES H. AND LYNNE CORBETT, AND WILLIAM H. AND JEANNE H. PIERSON by Stephen G. Davidson, Attorney, for the REZONING, FROM AG-AGRICULTURAL DISTRICT TO RT-RESIDENTIAL TRANSITIONAL DISTRICT of Tracts 11, 12, and the East 1/2 of Tract 13 in the Northwest 1/4 of Plat of Section 36, Township 44 South, Range 42 East, as recorded in Plat Book 3, Page 10, Less the South 200.00 feet of the East 1/2 of said Tract 13; the South 260.11 feet of the West 1/2 of said Tract 11, and the South 15.00 feet for Roadway Easement. Said property located on the north side of Corbett Road (55th Avenue South), approximately .2 mile west of Military Trail (S.R. 809) and approximately .5 mile north of Lantana West Road (S.R. 812), was approved as advertised.

Commissioner Koehler , moved for approval of the petition.

put to a vote, the vote was as follows:




