

RESOLUTION NO. R-79- 495

RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 79-60 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 29 March 1979.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session the 29th day of March, 1979, that petition No. 79-60 the petition of HERBERT HERSHKOWITZ for a SPECIAL EXCEPTION TO ALLOW THE PARKING OF ONE (1) MOBILE HOME AS A TEMPORARY RESIDENCE on a parcel of land situated in Section 9, Township 43 South, Range 40 East, bounded and described as follows: Commencing at the Northeast corner of Section 9, Township 43 South, Range 40 East; thence, North 89°39'08" West, along the North line of said Section 9, a distance of 2296.33 feet to a Point of Beginning; thence, South 44°53'10" East, a distance of 756.00 feet; thence, South 45°06'50" West, a distance of 426.34 feet; thence, South 51°47'28" West, a distance of 105.91 feet; thence, North 38°12'32" West, a distance of 756.00 feet; thence, North 51°47'28" East, a distance of 61.82 feet; thence, North 45°06'50" East, a distance of 382.25 feet to the Point of Beginning. Subject to a non-exclusive easement for ingress and egress over the North 100.00 feet and the Southeast 30.00 feet; described according to a Plat made by Albert L. Pyle, R.L.S., being known as Tract 32 of Sunny Urban Meadows, unrecorded. Said property located approximately five (5) miles north of S.R. 80 and approximately three (3) miles west of Seminole-Pratt Whitney Road in an AG-Agricultural District, was approved as advertised subject to the following conditions:

1. Petitioner shall join the Homeowners' Association prior to receiving any permits according to the Affidavit of Exemption documents of "Sunny Urban Meadows."
2. The term of the Special Exception allowing the parking of the mobile home as a temporary residence shall be limited to a maximum of five (5) years because of the changing character of the area.

Commissioner Foster, moved for approval of the petition.
