

RESOLUTION NO. R-79-928

RESOLUTION APPROVING ZONING PETITION

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. 79-116 was presented to the Board of County Commissioners of Palm Beach County at its public hearing conducted on 28 June 1979.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, assembled in regular session the 28th day of June, 1979, that petition No. 79-116 the petition of A.G. SCHAEERER by Kieran Kilday, for Kieran Kilday, Inc., Agent, for the REZONING, FROM CN-NEIGHBORHOOD COMMERCIAL DISTRICT, IN PART, AND RM-RESIDENTIAL MULTIPLE FAMILY DISTRICT (MEDIUM DENSITY), IN PART, TO CG-GENERAL COMMERCIAL DISTRICT on Lot 'A', less the North 55 feet and less the West 100 feet, and Lot 'B', less the North 20 feet of the West 100 feet, Tract 16, Palm Beach Farms Co., Plat No. 7, in Section 30, Township 44 South, Range 43 East, as recorded in Plat Book 5, page 72. Said property located on the south side of Lucerne Avenue (S.R. 802), and on the east side of Kirk Road, was approved as advertised.
