- 1. Within ninety (90) days of Special Exception approval, petitioner shall convey to Palm Beach County forty (40) feet from centerline for the ultimate right-of-way for Fla-Mango Road.
- 2. Petitioner shall eliminate the southernmost drive.
- Petitioner shall align a new turnout at the southerlyparking area with Lin Mar Drive.
- Petitioner shall provide a grass play area subject to Code regulations.
- 5. Petitioner shall provide additional landscaping of all perimeter area surrounding the subject facility, subject to the approval of the Department of Planning, Zoning and Building.
