## RESOLUTION APPROVING ZONING PETITION

TO ALLOW THE PARKING OF ONE (1) MOBILE HOME AS A TEMPORARY RESIDENCE on the East 5 acres of the West 15 acres of Tract 34, Block "F", Loxahatchee Groves, also described as the West 384.90 feet of the East 1154.62 feet

of Tract 34, Block "F", Loxahatchee Groves, in Section 27, Township 43
South, Range 41 East, as recorded in Plat Book 12, page 29; together
with an easement for ingress and egress over the South 30 feet of said
Tract 34, Block "F", also subject to a utility and drainage easement
over the North 15 feet thereof. Said property located on the north side
