RESOLUTION NO. R-87-8

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, IMPOSING LIENS AGAINST CERTAIN RESIDENTIAL UNITS PURSUANT TO ORDINANCE NO. 84-10 AND AMENDMENTS THERETO FOR DISTRICT 6.

WHEREAS, the provisions of Palm Beach County Ordinance No. 84-10 and amendments thereto, provide for the levy of a special assessment against residential units within the benefit units in the unincorporated areas of Palm Beach County for mandatory garbage and waste collection and disposal, and.

WHEREAS, said Ordinances provide that payment of the annual special assessments are delinquent if not paid by April 1st of each service year, and

WHEREAS, said Ordinances provide certain time periods for the payment of quarterly installment payments, and

WHEREAS, the Board of County Commissioners has received the list of outstanding and delinquent annual special assessments from the Clerk of the Circuit Court acting as Clerk to the Board for those residential units in District 6 who failed to timely pay the special assessments within the time periods described above and contained in said Ordinances, and.

WHEREAS, the Board of County Commissioners have reviewed said list and finds that under the terms of said Ordinances such total amounts due and unpaid as contained in said list are appropriate, and

WHEREAS, under the terms of said Ordinances said delinquent special assessments shall constitute and are imposed as liens against such residential units as of the date the Board approves the Resolution containing the information required under the terms of those Ordinances.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that under the terms of Palm Beach County Ordinance No. 84-10 and amendments thereto, those residential units in District 6 contained on the list supplied by the Clerk of the Circuit Court acting as Clerk to the Board are delinquent in the payment of the annual special assessment and as a result thereof a lien is hereby imposed against those residential units described on the said list in the amounts contained therein, said list adopted and incorporated herein by reference.
