Marcus, Chairman, to Revoke a Special Exception for a Planned Unit Development, on Tracts 4, 5, 6, 7, 8, 9, 16, 17, 18, 19, 23 and 21, Block 17; the South 1/2 of Tracts 32 and 33, and Tracts 44, 45, 46 and 47, Block 10, Palm Beach Farms Company Plat No. 3, in Sections 6 and 7, Township 44 South, Range 42 East, as recorded in Plat Gook 2, pages 46 and 47, located on on the east side of State Road 7, and on the north and south side of Dillman Road, was approved as advertised.
