

RESOLUTION NO. R-88-164

RESOLUTION WITHDRAWING ZONING PETITION S86-32

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as providea for in Chapter 402.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

WHEREAS, Petition No. S86-32 was presented to the Board of County Commissioners of Palm Beach County, sitting as the Zoning Authority, at its public hearing conducted on November 18, 1986 and

WHEREAS, the Board of County Canmissioners has considered the evidence and testimony presented by the applicant ana other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning Commission; and

WHEREAS, the Boara of County Commissioners made the following finuings of fact:

1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA that: Petition No. S86-32 (regarding Zoning Petition No. 80-131, Resolution No. R-80-1229), the petition of the Board of County Commissioners, by Karen T. Marcus, Chairman, to revoke the Special Exception for a Planned Canmercial Development, on the the West 200 feet of Block 21, Block 2, LAGUNA PARK NO. 1, in Section 8, Township 44 South, Range 43 East as recorded in Plat Book 21, page 53, Less the North 22.4 feet and Less the West 17 feet thereof, located on the east side of Congress Avenue, approximately 100 feet north of Melaleuca Drive, was withdrawn, without prejudice.

A motion to withdraw, without prejudice, Petition No. S86-32 was offered by Commissioner Owens, who moved its adoption. The motion was seconded by Commissioner Adams, and upon being put to a vote, the vote was as follows:
