## RESOLUTION WITHDRAWING ZONING PETITION \$86-47

WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 482.5 of the Palm Beach County Zoning Code Ordinance No. 73-2 have been satisfied; and

KHEREAS, Petition No. S86-47 was presented to the Board of County Canmissioners of Palm Beach County, sitting as the Zoning Authority, at its public hearing conducted on November 18, 1986 and

WHEREAS, the Board of County Cannissioners has considered the evidence and testimony presented by the applicant and other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning Commission; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA that: Petition No. S86-47 (regarding Zoning Petition No. 77-48, Resolution No. R-77-483), the petition of the Board of County Canmissioners, by Karen T. Marcus, Chairman, to revoke the Special Exception for a Planned Commercial Development on that part of Tracts 20 and 21 lying South of Hillsboro and/or the West Palm Beach Canal, and all of Tracts 22 and 23, in Block 8; Tracts 4, 5, 6, 7, and 8, and Tract 17, less the South 24 feet thereof, and Tract 18, in Block 10; of PALM BEACH FARMS CO. PLAT NO. 3, according to the Plat thereof on file in the Office of the Clerk of the Circuit Court in and for Palm Beach County, Florida, in Plat Book 2 at Pages 45 to 54 inclusive, located at the southeast corner of Southern Boulevard and State Road 7, was withdrawn, without prejudice.

A motion to withdraw, without prejudice, Petition No. S86-47 was offered by Canmissioner Owens, who moved its adoption. The motion was seconded by Canmissioner Adams, and upon being put to a vote, the vote was as follows:
