WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the applicant and other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning Commission; and

1. This proposal is consistent with the requirements of the Comprehensive Plan and local land development regulations.

NOW, THEREFORE, BE IT RESOLVED EY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA that: Petition No. \$86-48, the petition of the Board of County Cammissioners, by Karen T. Marcus, Chairman, for Rezoning from CG-General Cammercial Zoning District to RS-Single Family Residential Zoning District on A parcel of land lying in Tract 6, Block 9, PALM BEACH FARM COMPANY'S PLANT NO. 3, according to the Plat thereof on file in the office of the Clerk of the Circuit Court in and for Palm Beach County, Florida, in Plat Book 2, Page 45, more particularly described as follows: Commencing at the Southwest corner of said Tract 6; thence Easterly along the South line of said Tract 6, a distance of 156; feet to the Point of Beginning; thence continue along said South line a distance of 141.35 feet; thence Northerly, along a line parallel to the West Right-of-hay line of said State Road #7, a distance of 400.47 feet; thence westerly parallel with the Southerly, parallel with the West line of said Tract 6, a distance of 158.02 feet; thence Southerly, parallel with the West line of said Tract 6, a distance of 400 feet to the Point of Beginning. SUBJECT to restrictions, reservations and easements of record, if any and matters appearing in ORB 1794, page 842, located on the north side of Southern Boulevard, approximately 175 feet west of State Road 7, was withdrawn, without prejudice.
