WHEREAS, the Board of County Commissioners, as the governing body, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and hearing requirements as provided for in Chapter 402.5 of the Palm Beach County Zoning Code have been satisfied; and

WHEREAS, petition No. 80-188(B) was presented to the Board of County Commissioners of Palm Beach County, sitting as the Zoning Authority, at its public hearing conducted on September 27, 1990; and

WHEREAS, the Board of County Commissioners, sitting as the Zoning Authority, has considered the evidence and testimony presented by the applicant and other interested parties and the recommendations of the various county review agencies and the recommendations of the Planning Commission; and

1. This proposal is consistent with the requirements of the Comprehensive and local land development regulations.

BENTZ, AGENT, for a MODIFICATION OF COMMISSION REOUIREMENTS on a parcel of land lying on the east 330.00 feet of the west 510.00 feet of the northeast 1/4 of the northwest 1/4 of the northeast 1/4 of Section 10, Township 44 South, Range 42 east and being located on the south side of Summit Boulevard, 1 mile east of Jog Road, in a RE-Residential Estate Zoning District, was approved on September 27, 1990, as advertised, subject to the following conditions:
