RESOLUTION AMENDING RESOLUTION NO R-90-1304
RESOLUTION APPROVING ZONING PETITION OF
WILLIE H DAY AND JACK E COOK
PETITION NO 87-32(A)

WHEREAS, WILLIE H DAY AND JACK E COOK petitioned the Palm Beach County Planning Commission and the Board of County Commissioners sitting as the final zoning authority, on February 1 1990 and February 22, 1990, respectively, for the SPECIAL EXCEPTION TO AMEND THE MASTER PLAN FOR BEACON PINES EAST AND WEST PLANNED UNIT DEVELOPMENT TO DECREASE THE LAND AREA, and

WHEREAS, Resolution No R-90-1304 adopted August 7, 1990 confirming the action of the Board of County Commissioners sitting as the final zoning authority on February 22, 1990, inadvertently failed to clarify the request and contained an error in the property location, and

WHEREAS, the request of Resolution No R-90-1304 reads as follows

"for a SPECIAL EXCEPTION TO AMEND THE MASTER PLAN FOR BEACON PINES EAST AND WEST PLANNED UNIT DEVELOPMENT TO DECREASE THE LAND AREA", and

WHEREAS, the request of said zoning resolution should have read

for a SPECIAL EXCEPTION TO AMEND THE MASTER PLAN FOR BEACON PINES EAST AND WEST PLANNED UNIT DEVELOPMENT TO DECREASE THE LAND AREA OF BEACON PINES EAST, and

WHEREAS, the property location of Resolution No R-90-1304 reads as follows

"and being located on the southwest corner of the intersection of Skees Road and 15th Street North", and

WHEREAS, the property location of said zoning resolution should have read

and being located on the ~~southwest~~ southeast corner of the intersection of Skees Road and ~~15th Street North~~ Hoffman Road

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that

- 1 The foregoing recitals are hereby affirmed and ratified
- 2 The request and property location of Resolution No R-90-1304 are hereby amended


