RESOLUTION APPROVING ZONING PETITION Z99-041 OFFICIAL ZONING MAP AMENDMENT (REZONING) PETITION OF HOME DEVELOPMENT CORP BY H.P. TOMPKINS, AGENT (THE ENCLAVE SHOPPES)

WHEREAS, the Board of County Commissioners, as the governing body of Palm Beach County, Florida, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the notice and public hearing requirements, as provided for in Article 5 (Development Review Procedures) of the Palm Beach County Unified Land Development Code (Ordinance 92-20, as amended), have been satisfied; and

WHEREAS, Zoning Petition Z99-041 was presented to the Board of County Commissioners at a public hearing conducted on January 27,2000; and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the petitioner and other interested parties, the recommendations of the various county review agencies, and the recommendation of the Zoning Commission; and

WHEREAS, the Board of County Commissioners made the following findings of fact:

- 1. This official zoning map amendment (rezoning) is consistent with the Palm Beach County Comprehensive Plan;
- 2. This official zoning map amendment (rezoning) is consistent with the requirements of the Palm Beach County Unified Land Development Code;
- 3. This official zoning map amendment (rezoning) is compatible with surrounding uses and zones, as defined in the Palm Beach County Unified Land Development Code, is generally consistent with existing uses and zones surrounding the subject land, and is the appropriate zoning district for the land;
- 4. This official zoning map amendment (rezoning) does not result in significantly adverse impacts on the natural environment, including but not limited to water, air, stormwater management, wildlife, vegetation, wetlands, and the natural functioning of the environment;
- 5. This official zoning map amendment (rezoning) will result in a logical and orderly development pattern;
- 6. This official zoning map amendment (rezoning) complies with Article 11 (Adequate Public Facilities Standards) of the Palm Beach County Unified Land Development Code; and,
- 7. This official zoning map amendment (rezoning) is consistent with the requirements of all other applicable local land development regulations.

Petition Z99-041 Project No. 5563-000 WHEREAS, Article 5, Section 5.3.D.9 (Action by Board of County Commissioners) of the Palm Beach County Unified Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Zoning Petition Z99-041, the petition of Home Development Corp, by H.P. Tompkins, agent, for an OFFICIAL ZONING MAP AMENDMENT (REZONING) from the Agricultural Residential (AR) Zoning District to the Community Commercial (CC) Zoning District on a parcel of land legally described in EXHIBIT A, attached hereto and made a part hereof, and generally located as indicated on a vicinity sketch attached as EXHIBIT B, attached hereto and made a part hereof, was approved on January 27,2000 subject to the voluntary commitments described in EXHIBIT C, attached hereto and made a part hereof.

EXHIBIT B VICINITY SKETCH



VOLUNTARY COMMITMENTS

A. ALL PETITIONS

1. Development of the site is limited to the uses and site design as approve 1 by the Board of County Commissioners. The approved site plan is dated November 23, 1999. All modifications must be approved by the Boar1 of County Commissioners unless the proposed changes are required to neet voluntary commitments or are in accordance with the ULDC. (ONGOING: ZONING)

B. <u>BUILDING AND SITE DESIGN</u>

1. The property owner shall provide the City of Delray with a copy of the Palm Beach County certified site plan, and any major changes proposed to the site plan shall be reviewed by the City. (DRC: ZONING-City of Delray)

C. <u>LANDSCAPING ALONG EAST PROPERTY LINES</u> (ADJACENT TO MARKLAND LANE)

- 1. Landscaping and buffering along the east property lines shall be upgraded to include:
 - a. A minimum fifteen (15) foot wide landscape buffer strip;
 - b. One (1) canopy tree planted every twenty (20) feet on center;
 - c. One (1) palm or pine tree for each thirty (30) linearfeet of frontage, with a maximum spacing of sixty (60) feet between clusters;
 - d. A minimumone (1) to two (2) foot high undulating berm, with an aver age height of one and one-half (1.5) feet, measured from the top of the curb; and,
 - e. Thirty (30) inch high shrub or hedge material, spaced no more than twenty four (24) inches on center at installation, to be maintained at a minimum height of sixty (60) inches. (CO: LANDSCAPE Zonin(1)
 - f. Petitioner shall install/incorporate a wall or fence into the landscape buffer between the first and second driveways to achieve an overall height of eight (8') feet.

D. <u>LANDSCAPING ALONG NORTH PROPERTY LINE</u> (ADJACENT TO ATLANTIC AVENUE)

- 1. Landscaping and buffering along the north property line shall be upgraded to include:
 - a. A minimum twenty-eight (28) foot wide;
 - b. One (1) native canopy tree planted every twenty (20) feet on cer ter;
 - c. One (1) native palm or pine tree for each thirty (30) linear feet of frontage, with a maximum spacing of sixty (60) feet between clusters;
 - d. A minimum two (2) to three (3) foot high undulating berm, with an average height of two and one half $(2\frac{1}{2})$ feet, measured from the top of the curb; and,
 - e. Thirty (30) inch high shrub or hedge material located on the plateau of the berm spaced twenty-four (24) inches on center at installation to be maintained a minimum of sixty (60) inches in height. (CO: LANDSCAPE Zoning)

E. ENGINEERING

- 1. Prior to the issuance of a building permit the property owner shall convey to Palm Beach County Land Development Division by road right-of-way warranty deed additional right of way for:
 - a. the construction of a right turn lane west approach on West Atlantic Avenue at Markland Lane. This right-of-wayshall be a minimum of 280 feet in storage length, twelve feet in width and a taper length of 50 feet or as approved by the County Engineer.
 - b. Markland Lane, 40 feet from centerline.

Right of way conveyance shall be along the projects entire frontage and shall be free of all encumbrances and encroachments. Developer shall provide Falm Beach County with sufficient documentation acceptable to the Right of \ Vay Acquisition Section to ensure that the property is free of all encumbrances and encroachments. Right-of-way conveyances shall also include "Corner Clips" where appropriate as determined by the County Engineer. (BLDG PERF AIT: MONITORING-Eng)

- 2. The Property owner shall construct a right turn lane west approach on West Atlantic Ave at Markland Lane.
 - a. This construction shall be concurrent with the paving and drainage improvements for the site. Any and all costs associated with the construction shall be paid by the property owner. These costs shall include, but are not limited to, utility relocations and acquisition of any additional required right-of-way.
 - b. Permits required by Palm Beach County for this construction shall be obtained prior to the issuance of the first Building Permit. (BLDG PERMIT: Monitoring-Eng)
 - c. Construction shall be completed prior to the issuance of the first Certificate of Occupancy. (CO: MONITORING-Eng)

3. LANDSCAPE WITHIN MEDIAN OF WEST ATLANTIC AVENUE

Prior to issuance of a building permit, the property owner shall app y to a. the Palm Beach County Engineeringand Public Works Departmen: for a permit to landscape the adjacent median of West Atlantic Ave nue Right-of-way. This permit, to be completed by the property owner, shall name Palm Beach County as the applicant. As part of this permit process, the property owner shall enter into a Right of Way, Landscape Maintenance, Removal, and Indemnification Agreement. landscaping is permitted by the Florida Department of Transportat on, landscaping shall, at a minimum, consist of the "Low Cost Planing" Concept" outlined in the Palm Beach County Engineering and Public Works Department March 1994 Streetscape Standards. The property owner shall also be responsible to supplement any existing landscape material previously planted in this median and all new landscape material shall be consistent with the landscaping theme adopted for this All landscape material, installation, and maintenaice requirements shall be subject to the standards set forth by the Streetscape Standards. If all xeriscape material is utilized, the wate ing of the plant material during the initial heal-in period shall be the

- responsibility of the property owner. Alternative species other 1 han those listed in the Countystandards may be allowed subject to approval by the County Engineer. (BLDG PERMIT:MONITORING Eng)
- b. All required median landscaping, including an irrigation system if required, shall be installed at the property owners expense. landscaping, paver block or similar materials shall be the perpetual maintenance obligation of the petitioner and its successors, or assigns or duly established Property Owner's Association or maintenance I nay be assumed by the County upon payment equal to the long term maintenance cost, in accordance with the adopted policy approve 1 by the Board of County Commissioners. All existing landscape matterial shall also be the perpetual maintenance obligation of the petitioner and its successors, heirs or assignees or duly established Property Owr er's Association and/or Homeowners3Association. Perpetual maintenance includes, but is not limited to, pruning, fertilizing, irrigation, and alter late watering of Xeriscape material during periods of drought in order to maintain healthy plant material. All landscape materials hall be installed prior to the issuance of a certificate of occupancy. (CO: MONITORING-Eng)
- c. If the Countydoes not assume maintenance responsibility, the property owners documents or other restrictive covenant documents, eviden sing the maintenance obligation shall be established or amended as required and shall be approved and recorded prior to the issuance of a Building Permit. (BLDG PERMIT: MONITORING-Eng)

F. <u>LANDSCAPINGALONG SOUTHAND WEST PROPERTY LINES (ADJACENT TO RESIDENTIAL)</u>

- 1. Landscaping and buffering shall be upgraded to include:
 - a. A minimum fifteen (15) foot wide buffer strip;
 - b. One (1) native canopy tree planted every twenty (20) feet on cer ter;
 - c. One(1) native palmor pine tree for each thirty (30) linear feet of prop∋rty line, with a maximum spacing of sixty (60) feet between clusters
 - d. Six (6) feet high screen wall setback ten (10) feet from the south and west property lines and terminating twenty-five (25) feet south of W. Atlantic Avenue right-of-way; and,
 - e. Shrub or hedge material located on both sides of the wall to be maintained a minimum of sixty (60) inches in height. (CO: LANDSCAPE-Zoning)

G. <u>SIGNS</u>

- 1. Freestanding sign located at the corner of W. Atlantic Avenue and Markl and Lane shall be limited as follows:
 - Maximum sign height, measured from finished grade to highestpo ntten (10) feet;
 - b. Maximum sign face area per side 100 square feet;
 - c. Maximum number of signs one (1); and
 - d. Style monument style only. (CO: BLDG)

H. LANDSCAPE - FOUNDATION PLANTING

1. Landscape islands shall be provided along the front and sides of all structures. The minimum width of the required landscape islands shall be five (5') feet. The combined length of the required landscape islands shall be no less than 40% of the total length of the applicable side of the structure. All required landscape islands shall be planted with a minimum of one (1) tree or palm every twenty (20) feet on center and appropriate ground cover. (DRC: LANDSCAPE)

I. <u>COMPLIANCE</u>

- 1. Ingranting this approval, the Board of County Commissioners relied upon the oral and written representations of the petitioner both on the record and as part of the application process. Deviations from or violation of these representations shall cause the approval to be presented to the Board of County Commissioners for review under the compliance commitment of this approval. (ONGOING: MONITORING Zoning)
- 2. Failure to comply with any of the voluntary commitments for the subject property at any time may result in:
 - a. The issuance of a stop work order; the issuance of a cease and desist order; the denial or revocation of a building permit; the denial or revocation of a Certificate of Occupancy; the denial of any other per nit, license or approval to any developer, owner, lessee, or user of the subject property; the revocation of any other permit, license or approval from any developer, owner, lessee, or user of the subject property; revocation of any concurrency; and/or
 - b. The revocation of the Official Map Amendment, Conditional L se, Requested Use, Development Order Amendment, and/or any ol her zoning approval; and/or
 - c. A requirement of the development to conform with the standards of the ULDC at the time of the finding of non-compliance, or the addition or modification of conditions reasonably related to the failure to comply with existing conditions; and/or
 - d. Referral to code enforcement; and/or
 - e. Imposition of entitlement density or intensity.

Staff may be directed by the Executive Director of PZ&B or a majority vote of the Code Enforcement Board to schedule a Status Report before the body which approved the Official Zoning Map Amendment, Conditional Use, Requested Use, Development Order Amendment, and/or other zoring approval, in accordance with the provisions of Section 5.8 of the ULDC, in response to any flagrant violation and/or continued violation of any voluntary commitment.

Appeals of any departmental administrative actions hereunder may be talten to the Palm Beach County Board of Adjustment or as otherwise provided in the Unified Land Development Code (ULDC), as amended. Appeals of any revocation of an Official Zoning Map Amendment, Conditional Use, Requested Use, Development Order Amendment or other actions based on a Board of County Commission decision shall be by petition for writ of certiorari to the Fifteenth Judicial Circuit. (MONITORING)
