RESOLUTION CORRECTING RESOLUTION R-2001-0430  
RESOLUTION APPROVING ZONING PETITION OF WAL-MART STORES INC.  
SAM'S WHOLESALE CLUB  
PETITION DOA1 975069(G)

WHEREAS, Wal-mart Stores Inc., petitioned the Palm Beach County Board of County Commissioners on March 22, 2001 for a Development Order Amendment (DOA) to reconfigure site plan and add square footage; and

WHEREAS, Resolution R-2001-0430, adopted on March 22, 2001 confirming the action of the Board of County Commissioners inadvertently contained an error in Condition A.1 of Exhibit C; and

WHEREAS, Condition A.1 of Exhibit C of Resolution R-2001-0430 should have read as follows:

1. **All previous conditions of approval applicable to the subject property, as contained in Resolutions R-75-463, R-84-I 098, R-89-741, R-89-I 054, and R-90-1887 have been consolidated as contained herein. The petitioner shall comply with all previous conditions of approval and deadlines previously established by Section 5.8 of the ULDC, unless expressly modified. (MONITORING) (Previously Condition A.1 of Resolution R-95-0269, Petition DOA75-069(F))**

Is hereby amended to read:

Condition A. 1 of Resolution R-95-0269, Petition DOA75-069(F) which currently states:

All previous conditions of approval applicable to the subject property, as contained in Resolutions R-75-463 (~~Petition 73-2~~) (Petition, R-84-1098 (Petition 75-069A), R-89-741 (Petition 75-069C), R-90-1 887(Petition 75-069E) and R-95-0269 (Petition 75-069F) have been consolidated as contained herein. The petitioner shall comply with all previous conditions of approval and deadlines previously established by Section 5.8 of the ULDC, unless expressly modified. (MONITORING)

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby affirmed and ratified.
2. Condition A.1 of Exhibit C of Resolution R-2001-0430 is hereby corrected.
