WHEREAS, Serge Gerome petitioned the Palm Beach County Board of **County** Commissioners on August 30, 1993, for a Class A Conditional **Use** (CA) allowing a church or place of worship with accessory day care (30 children).

WHEREAS, Resolution No. R-93-1025 adopted August 30, 1993, confirming the action of the Board of County Commissioners, inadvertently contained an incorrect legal description; and

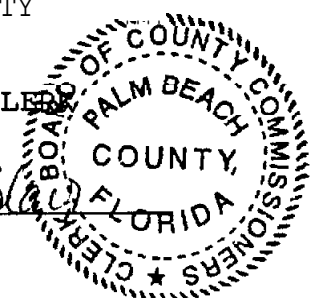
