RESOLUTION CORRECTING RESOLUTION R-99-1614
RESOLUTION APPROVING ZONING PETITION OF
DELRAY FUNERAL HOMES, LTD.
(WOOLBRIGHT & JOG MUPD)
PETITION PDD99-035

WHEREAS, Delray Funeral Homes, LTD., petitioned the Palm Beach County Board of County Commissioners on August 26, 1999 for an Official Zoning Map Amendment to a Planned Development District (PDD) from Agricultural Residential (AR) to Multiple Use Planned Development (MUPD) with a funeral home and financial institution; and

WHEREAS, Resolution R-99-1614, adopted on August 26, 1999 confirming the action of the Board of County Commissioners inadvertently contained errors in Exhibit C; and

WHEREAS, Conditions H.1.d and H.2.d of Exhibit C of Resolution R-99-1614 should have read as follows:

- H.1. Freestanding sign fronting on Jog Road shall be limited as follows:
- a. Maximum sign height six (6) feet measured from the finished grade at the base of the sign with a two (2) foot hedge for four (4) feet of sign exposure;
 - b. Maximum single face area per side - sixty (60) square feet;
 - c. Maximum number of signs - one (1);
 - d. Location - to be located ~~within thirty (30) feet of entrance~~ on two foot berm;
 - e. Monument style only. (CO: BLDG)
2. Freestanding sign fronting on Woolbright Road at entrance to financial institution shall be limited as follows:
- a. Maximum sign height - six (6) feet; measured from the finished grade at base of sign with a two (2) foot hedge for four (4) feet of sign exposure
 - b. Maximum single face area per side - sixty (60) square feet;
 - c. Maximum number of signs - one (1);
 - d. Location - to be located ~~within thirty (30) feet of entrance~~ on two foot berm;
 - e. Monument style only. (CO: BLDG)

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby affirmed and ratified.
2. Conditions H.1.d and H.2.d of Exhibit C of Resolution R-99-1614 are hereby corrected.

Commissioner Roberts moved for the approval of the Resolution.
