RESOLUTION APPROVING ZONING APPLICATION CA2005-153 (CONTROL NO. 2005-064) CLASS A CONDITIONAL USE PETITION OF MEDHI POURPAKI BY DROOR AND ASSOCIATES INC. (EAST COAST LIMO)

WHEREAS, the Board of County Commissioners, as the governing body of Palm Beach County, Florida, pursuant to the authority vested in Chapter 163 and Chapter 125, Florida Statutes, is authorized and empowered to consider petitions relating to zoning; and

WHEREAS, the Board of County Commissioners, pursuant to Article 2 (Development Review Procedures) of the Palm Beach County Unified Land Development Code (Ordinance 2003-067) is authorized and empowered to consider, approve, approve with conditions or deny Class A Conditional Uses; and

WHEREAS, the notice and hearing requirements, as provided for in Article 2 of the Palm Beach County Unified Land Development Code have been satisfied; and

WHEREAS, Zoning Application CA2005-153 was presented to the Board of County Commissioners at a public hearing conducted on July 28, 2005; and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the petitioner and other interested parties, the recommendations of the various county review agencies, and the recommendations of the Zoning Commission; and

WHEREAS, this approval is subject to Article 2.E (Compliance with Time Limitations) of the Palm Beach County Unified Land Development Code (ULDC) and other provisions requiring that development commence in a timely manner; and

WHEREAS, the Board of County Commissioners has considered the findings in the staff report and the following findings of fact:

- 1. This Class A Conditional Use is consistent with the Palm Beach County Comprehensive Plan.
- 2. This Class A Conditional Use complies with relevant and appropriate portions of Article 6, Supplementary Use Standards of the Palm Beach County Unified Land Development Code.
- 3. This Class A Conditional Use is consistent with the requirements of the Palm Beach County Unified Land Development Code.
- 4. This Class A Conditional Use, with conditions as adopted, is compatible as defined in the Palm Beach County Unified Land Development Code and generally consistent with the uses and character of the land surrounding and in the vicinity of the land proposed for development.
- 5. This Class A Conditional Use, with conditions as adopted, complies with standards imposed on it by all other applicable provisions of the Palm Beach County Unified Land Development Code for use, layout, function, and general development characteristics.
- 6. This Class A Conditional Use meets applicable local land development regulations.

- 7. This Class A Conditional Use, with conditions as adopted, minimizes adverse effects, including visual impact and intensity of the proposed use on adjacent lands.
- 8. This Class A Conditional Use has a concurrency determination and complies with Article 2.F, Concurrency of the ULDC.
- This Class A Conditional Use, with conditions as adopted, minimizes environmental impacts, including but not limited to water, air, stormwater management, wildlife, vegetation, wetlands and the natural functioning of the environment.
- 10. This Class A Conditional Use, with conditions as adopted, will result in logical, timely and orderly development patterns.

WHEREAS, Article 2 of the Palm Beach County Unified Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Zoning Application CA2005-153, the petition of Medhi Pourpaki, by Droor and Associates Inc., agent, for a Class A Conditional Use to allow a dispatching office in the General Commercial Zoning District, on a parcel of land legally described in EXHIBIT A, attached hereto and made a part hereof, and generally located as shown on a vicinity sketch as indicated in EXHIBIT B, attached hereto and made a part hereof, was approved on July 28, 2005, subject to the conditions of approval described in EXHIBIT C, attached hereto and made a part hereof.

VICINITY SKETCH



CONDITIONS OF APPROVAL

ALL PETITIONS

 Development of the site is limited to the site design as approved by the Board of County Commissioners. The approved site plan is dated April 27, 2005. All modifications must be approved by the Board of County Commissioners unless the proposed changes are required to meet conditions of approval or are in accordance with the ULDC. (DRO: ZONING - Zoning)

ARCHITECTURAL REVIEW

- 1. At time of submittal for final Development Review Officer (DRO) approval, the architectural elevations for the building shall be submitted simultaneously with the site plan for final architectural review and approval. Elevations shall be designed to be consistent with Article 5.C and Article 3.B.15.G. of the ULDC. Development shall be consistent with the approved architectural elevations, the DRO approved site plan, all applicable conditions of approval, and all ULDC requirements. (DRO: ARCH REVIEW Zoning)
- 2. Prior to final approval by the Development Review Officer (DRO), architectural elevations for any freestanding signage and the ornamental gates shall be submitted for review and approval by the Architectural Review Section. All elevations shall be:
 - a. given an architectural treatment that is generally consistent with the architectural character of the office building;
 - b. subject to review and approval by the Architectural Review Section; and.
 - c. reflected on the Regulating Plan. (DRO: ARCH REVIEW Zoning)

BUILDING AND SITE DESIGN

- A six (6) foot high vinyl coated chain link fence shall be installed on the site in accordance with the site plan dated April 27, 2005. (ONGOING: ZONING - Zoning)
- 2. The vinyl coated chain link fence along the north property line shall be attached to the northeast and northwest corners of the building. (ONGOING: ZONING Zoning)
- 3. An ornamental gate shall be provided at each entrance from Westgate Avenue and Suwanne Drive. (ONGOING: ZONING Zoning)

ENGINEERING

1. In order to comply with the mandatory Traffic Performance Standards, the Developer shall be restricted to the following phasing schedule:

No Building Permits for the site may be issued after July 28, 2008.

A time extension for this condition may be approved by the County Engineer based upon an approved Traffic Study which complies with Mandatory Traffic Performance Standards in place at the time of the request. This extension request shall be made pursuant to the requirements of Article 2 Section E of the Unified Land Development Code. (DATE: MONITORING - Eng)

- 2. Prior to issuance of a Building Permit, the Developer shall plat the subject property in accordance with provisions of Article 11 of the Unified Land Development Code. (BLDG PERMIT: MONITORING Eng)
- CONVEYANCE OF CORNER CLIPS

The property owner shall convey to Palm Beach County Land Development Division by warranty deed for a 25-foot corner clip at the intersections of:

Westgate Avenue and Suwanee Drive; and, Nokomis Avenue and Suwanee Drive.

These corner clips shall be conveyed prior to the issuance of the first Building Permit. This right of way shall be free of all encumbrances and encroachments. The Developer shall provide Palm Beach County with sufficient documentation acceptable to the Right of Way Acquisition Section to ensure that the property is free of all encumbrances and encroachments. (BLDG PERMIT: MONITORING - Eng)

4. The concurrency approval is subject to the project aggregation rule set forth in the Traffic Performance Standards Ordinance. (ONGOING: ENG - Eng)

HEALTH

1. Property owners and operators of facilities generating industrial, hazardous or toxic waste shall not deposit or cause to be deposited any such waste into the sanitary sewer system unless adequate pretreatment facilities approved by the Florida Department of Environmental Protection, the Palm Beach County Health Department, and the agency responsible for sewage works are provided and used. (ONGOING: CODE ENF - Health)

ZONING - LANDSCAPING-STANDARD

- 1. A minimum of fifty (50) percent of all trees to be planted in the landscape buffers shall meet the following minimum standards at installation:
 - a. tree height: Fourteen (14) feet;
 - b. trunk diameter: three and one-half (3.5) inches measured at four and one-half (4.5) feet above grade;
 - c. canopy diameter: Seven (7) feet diameter shall be determined by the average canopy radius measured at three (3) points from the trunk to the outermost branch tip. Each radius shall measure a minimum of three and one-half (3.5) feet in length; and,
 - d. credit may be given for existing or relocated trees provided they meet ULDC requirements. (BLDG PERMIT: LANDSCAPE Zoning)
- 2. All palms required to be planted on the property by this approval shall meet the following minimum standards at installation:
 - palm heights: twelve (12) feet clear trunk;
 - b. clusters: staggered heights twelve (12) to eighteen (18) feet; and,
 - c. credit may be given for existing or relocated palms provided they meet current ULDC requirements. (BLDG PERMIT: LANDSCAPE -Zoning)
- 3. A group of three (3) or more palms may not supersede the requirement for a canopy tree in that location, unless specified herein. (BLDG PERMIT: LANDSCAPE Zoning)

 Field adjustment of plant material locations may be permitted to provide pedestrian sidewalks/bike paths and to accommodate transverse utility or drainage easements crossings and existing vegetation. (BLDG PERMIT: LANDSCAPE - Zoning)

ZONING – LANDSCAPING ALONG THE NORTH AND EAST PROPERTY LINES (FRONTAGES OF WESTGATE AVENUE AND SUWANEE DRIVE)

- 1. In addition to code requirements, landscaping and buffering along the north and east property lines shall be upgraded to include:
 - a. a minimum fifteen (15) foot wide landscape buffer strip. No width reduction or easement encroachment shall be permitted;
 - b. one (1) palm or pine tree for each twenty (20) linear feet of the property line with a maximum spacing of sixty (60) feet between clusters; and,
 - c. a continuous row of shrubs with a minimum height of six (6) feet at installation. (BLDG PERMIT: LANDSCAPE Zoning)

ZONING – LANDSCAPING ALONG THE SOUTH PROPERTY LINE (FRONTAGE OF NOKOMUS AVENUE)

- 1. In addition to code requirements, landscaping and buffering along the south property line shall be upgraded to include:
 - a. a minimum fifteen (15) foot wide landscape buffer strip. No width reduction or easement encroachment shall be permitted;
 - b. one (1) canopy tree for every twenty-five (25) linear feet of the property line planted alternating on each side of the required fence;
 - c. one (1) palm or pine tree for each twenty (20) linear feet of the property line with a maximum spacing of sixty (60) feet between clusters, to be planted on the exterior side of the required fence; and,
 - d. a continuous row of shrubs with a minimum height of six (6) feet at installation. (BLDG PERMIT: LANDSCAPE Zoning)

LIGHTING

- All outdoor, freestanding lighting fixtures shall not exceed fifteen (15) feet in height measured from finished grade to highest point. (ONGOING: BLDG - Zoning)
- 2. All outdoor, freestanding lighting fixtures shall be setback a minimum of fifty (50) feet from the south and east property lines. (ONGOING: BLDG Zoning)
- 3. All outdoor lighting shall be extinguished no later than 9:00 p.m. excluding security lighting only. (ONGOING: CODE ENF Zoning)
- The lighting conditions above shall not apply to proposed security or low voltage landscape/accent type lights used to emphasize plant material. (ONGOING: CODE ENF - Zoning)

PARKING

1. When the facility is not open, the entry gates shall be closed and locked. The gates shall be installed a minimum distance of twenty-five (25) feet from the property line, unless otherwise authorized by the County Engineer. (ONGOING: CODE ENF - Zoning)

SIGNS

1. Freestanding point of purchase signage shall be limited as follows:

- maximum sign height, measured from finished grade to highest a. point - five (5) feet;
- maximum sign face area per side 25 square feet; b.
- maximum number of signs one (1) for the entire site; C.
- style monument style only; and, d.
- location within thirty (30) feet of the entrance on Westgate e. Avenue measured from the edge of driveway pavement. (ONGOING: BLDG - Zoning)
- Wall signage shall be prohibited on the south and east facades of the 2. building. (ONGOING: BLDG - Zoning)

USE LIMITATIONS

- The site shall be limited to a dispatching office only. (ONGOING: CODE 1. ENF - Zoning)
- The site shall be limited to a maximum of 6 service or delivery vehicles at 2. any given time. (ONGOING: CODE ENF - Zoning)
- Outdoor speaker or public address systems shall not be permitted on the 3. property. (ONGOING: CODE ENF - Zoning)

UTILITIES

If any relocations/modifications to the County's existing facilities are 1. required that are a direct or indirect result of the development, the developer shall pay for the complete design and construction costs associated with these relocations/modifications. (ONGOING: PBCWUD -PBDWUD)

COMPLIANCE

- In granting this approval, the Board of County Commissioners relied upon 1. the oral and written representations of the petitioner both on the record and as part of the application process. Deviations from or violation of these representations shall cause the approval to be presented to the Board of County Commissioners for review under the compliance condition of this approval. (ONGOING: MONITORING - Zoning)
- 2. Failure to comply with any of the conditions of approval for the subject property at any time may result in:
 - The issuance of a stop work order; the issuance of a cease and a. desist order; the denial or revocation of a building permit; the denial or revocation of a Certificate of Occupancy; the denial of any other permit, license or approval to any developer, owner, lessee, or user of the subject property; the revocation of any other permit, license or approval from any developer, owner, lessee, or user of the subject property; revocation of any concurrency; and/or
 - The revocation of the Official Map Amendment, Conditional a. Use, Requested Use, Development Order Amendment, and/or any other zoning approval; and/or
 - b. A requirement of the development to conform with the standards of the ULDC at the time of the finding of non-compliance, or the addition or modification of conditions reasonably related to the failure to comply with existing conditions; and/or
 - Referral to code enforcement; and/or C
 - d. Imposition of entitlement density or intensity.

Staff may be directed by the Executive Director of PZ&B or a Code Enforcement Special Master to schedule a Status Report before the body

which approved the Official Zoning Map Amendment, Conditional Use, Requested Use, Development Order Amendment, and/or other zoning approval, in accordance with the provisions of Article 2.E of the ULDC, in response to any flagrant violation and/or continued violation of any condition of approval.

Appeals of any departmental administrative actions hereunder may be taken to the Palm Beach County Board of Adjustment or as otherwise provided in the Unified Land Development Code (ULDC), as amended. Appeals of any revocation of an Official Zoning Map Amendment, Conditional Use, Requested Use, Development Order Amendment or other actions based on a Board of County Commission decision shall be by petition for writ of certiorari to the Fifteenth Judicial Circuit. (ONGOING: MONITORING - Zoning)
