  - B. Construction for this intersection improvement shall be completed prior to the issuance of Certificates of Occupancy for more than 29,000 sf of Warehouse, 0.3 acres of outdoor storage, and 9,000 sf of Self Storage (the equivalent of 24 pm peak hour trips). (CO: MONITORING-Eng)
