WHEREAS, the notice and public hearing requirements, as provided for in Article 2 (Development Review Process) of the Palm Beach County Unified Land Development Code (Ordinance 2003-067, as amended) have been satisfied; and

WHEREAS, Zoning Application DOA-2008-01897 was presented to the Board of County Commissioners at a public hearing conducted on April 23, 2009; and

WHEREAS, the Board of County Commissioners has considered the evidence and testimony presented by the applicant and other interested parties, the recommendations of the various county review agencies, and the recommendation of the Zoning Commission; and

WHEREAS, this approval is subject to Article 2.E (Monitoring), of the Palm Beach County Unified Land Development Code and other provisions requiring that development commence in a timely manner; and

WHEREAS, the Board of County Commissioners has considered the findings in the staff report and the following findings of fact:

- 1. This Development Order Amendment is consistent with the Palm Beach County Comprehensive Plan;
- 2. This Development Order Amendment complies with applicable standards and provision of this Palm Beach County Unified Land Development Code for use, layout, function, and general development characteristics, including appropriate portions of Article 4.B, Supplementary Use Standards of the Palm Beach County Unified Land Development Code;
- 3. This Development Order Amendment, with conditions as adopted, is compatible and generally consistent with the uses and character of the land surrounding and in the vicinity of the land proposed for development;
- 4. This Development Order Amendment, with conditions as adopted, minimizes adverse effects, including visual impact and intensity of the property use on adjacent lands:
- 5. This Development Order Amendment, with conditions as adopted, minimizes environmental impacts, including, but not limited to, water, air, stormwater management, wildlife, vegetation, wetlands and the natural functioning of the environment;
- 6. This Development Order Amendment, with conditions as adopted, will result in logical, timely and orderly development patterns;
- 7. This Development Order Amendment is consistent with applicable neighborhood plans in accordance with BCC policy;

- 8. This Development Order Amendment has a concurrency determination and complies with Article 2.F, Concurrency of the ULDC.
- 9. This Development Order Amendment has demonstrated changed conditions or circumstances that necessitate a modification.

WHEREAS, Article 2.K.3.b (Action by BCC) of the Palm Beach County Unified Land Development Code requires that the action of the Board of County Commissioners be adopted by resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that Zoning Application DOA-2008-01897, the application of Atlantic Commons, by Atlantic Commons Associates, LLLP, agent, for a Development Order Amendment to to reconfigure master plan, add units, allow a model row, modify conditions of approval (PUD and PREM), and restart the commencement clock on a parcel of land legally described in EXHIBIT A, attached hereto and made a part hereof, and generally located as shown on a vicinity sketch attached as EXHIBIT B, attached hereto and made a part hereof, was approved on April 23, 2009, subject to the conditions of approval described in EXHIBIT C, attached hereto and made a part hereof.

PALM BEACH COUNTY VICINITY SKETCH / ZONING



Development of the site is limited to the uses approved by the Board of County Commissioners. The approved Preliminary Master Plan is dated February 13, 2009. All modifications must be approved by the Board of County Commissioners unless the proposed changes are required to meet conditions of approval or are in accordance with the ULDC. (ONGOING: ZONING - Zoning)

3.Based on Article 2.E of the Unified Land Development Code, this development order meets the requirements to receive a new three (3) year review date from the date of approval of this resolution. (ONGOING: MONITORING-Zoning)

CIVIC SITE DEDICATION

1.Previous PREM Condition 1 of Resolution No. R-2006-0516, Control No. 2004-525 which currently states:

Platting & Deed.

The property owner shall provide Palm Beach County Board of County Commissioners with a Statutory Warranty Deed on a net 2.47 acre public civic site (net usable area minus any buffers), in a location and form acceptable to Facilities, Development & Operations Department (FD&O) by November 1, 2006. Developer to plat and dedicate the civic site to Palm Beach County prior to conveying the deed, and shall have satisfied each of the following conditions prior to deed conveyance.

a) Title

Developer to provide a title policy insuring marketable title to Palm Beach County for the civic site and any easements that service the civic site as required by the County Attorney's office. All title exception documentation to be provided to County. Policy is subject to Property & Real Estate Management Department's (PREM) and County Attorney's

approval. The title policy to be insured to Palm Beach County for a dollar value based on current market appraisal of the proposed civic site or the Contract purchase price on a per acre basis if the contract purchase was concluded within the previous 24 month period. If an appraisal is required it shall be obtained by the Developer. The Developer shall release the County from all Declarations of Covenants and Conditions of the P.U.D. or other restrictive covenants as they may apply to the civic site.

b) Concurrency

Developer to assign sufficient traffic trip capacity such that the traffic volume associated with a County facility shall be attached to the civic site and recorded on the concurrency reservation for the entire PUD. The Developer shall be provided with input as to the size of a structure (and proposed use) which the civic site would support and the corresponding amount of trips.

c) Taxes

All ad valorem real estate taxes and assessments for the year of acceptance shall be prorated to include the day of acceptance.

d) Site condition

Civic site to be free and clear of all trash and debris at the time of acceptance of the Statutory Warranty Deed.

e) Retention and Drainage

Developer shall provide all retention, detention, and drainage required for any future development of the proposed civic site by the County. Developer shall specifically address the following issues:

- 1) The discharge of surface water from the proposed civic site into the Developer's water retention basins.
- 2) As easement across Developer's property from the proposed civic site to the retention basins, if required.

f) On-Site Inspections

By acceptance of these conditions developer agrees to allow the County to perform any on site inspections and testing deemed appropriate to support the acquisition of the civic site.

g) Vegetation Permit

Developer to perform a tree survey and obtain a vegetation clearing permit. If it is determined by PREM that clearing is not required at time of conveyance, the cost of such clearing shall be paid to the County.

h) Buildable Grade

Prepare civic site to buildable grade under the direction of the Facilities Development & Operations Department. Site shall be stabilized with 1) sod and watered or, 2) seeded, mulched and watered (until seed has established itself) to the satisfaction of Facilities Development and Operations.

i) Water & Sewer

Developer to provide water and sewer stubbed out to the property line and other required utilities as determined by PREM. (DATE:MONITORING-PREM) (Previous PREM condition 1of Reso. R-2005-2291, Control No. 2004-525)

2. The property owner shall provide Palm Beach County Board of County Commissioners with a Statutory Warranty Deed on a net 2.47 acre public civic site (net usable area minus any buffers), in a location and form acceptable to Facilities, Development & Operations Department (FD&O) by November 1, 2011. Developer to plat and dedicate the civic site to Palm Beach County prior to conveying the deed, and shall have satisfied each of the following conditions prior to deed conveyance.

a) Title

Developer to provide a title policy insuring marketable title to Palm Beach County for the civic site and any easements that service the civic site as required by the County Attorney's office. All title exception documentation to be provided to County. Policy is subject to Property & Real Estate Management Department's (PREM) and County Attorney's approval. The title policy to be insured to Palm Beach County for a dollar value based on current market appraisal of the proposed civic site or the Contract purchase price on a per acre basis if the contract purchase was concluded within the previous 24 month period. If an appraisal is required it shall be obtained by the Developer. The Developer shall release the County from all Declarations of Covenants and Conditions of the P.U.D. or other restrictive covenants as they may apply to the civic site.

b) Concurrency

Developer to assign sufficient traffic trip capacity such that the traffic volume associated with a County facility shall be attached to the civic site and recorded on the concurrency reservation for the entire PUD. The Developer shall be provided with input as to the size of a structure (and proposed use) which the civic site would support and the corresponding amount of trips.

c) Taxes

All ad valorem real estate taxes and assessments for the year of acceptance shall be prorated to include the day of acceptance.

d) Site condition

Civic site to be free and clear of all trash and debris at the time of acceptance of the Statutory Warranty Deed.

e) Retention and Drainage

Developer shall provide all retention, detention, and drainage required for any future development of the proposed civic site by the County. Developer shall specifically address the following issues:

- 1) The discharge of surface water from the proposed civic site into the Developer's water retention basins.
- 2) As easement across Developer's property from the proposed civic site to the retention basins, if required.

- b) If this parcel is a portion of Palm Beach Farms, sufficient data to make a mathematical overlay should be provided.
- c) The survey should include a location of any proposed water retention area that will border the civic site.

Survey is also subject to the County's approval of any proposed or existing easements within the proposed civic site and all title exceptions are to be shown on the survey. (DATE:MONITORING-PREM) (Previous PREM condition 2 of Reso. R-2005-2291, Control No. 2004-525)

- c. Canopy diameter: Seven (7) feet diameter shall be determined by the average canopy

radius measured at three (3) points from the trunk to the outermost branch tip. Each radius shall measure a minimum of three and one-half (3.5) feet in length; and,

- d. Credit may be given for existing or relocated trees provided they meet ULDC requirements. (BLDG PERMIT: LANDSCAPE Zoning) (Previous Landscape Condition 1 of Resolution R-2006-516, Control No. 2004-525)
- 2.All palms required to be planted on the property by this approval, except on individual residential lots, shall meet the following minimum standards at installation:
- a. palm heights: twelve (12) feet clear trunk:
- b. clusters: staggered heights twelve (12) to eighteen (18) feet; and,
- c. credit may be given for existing or relocated palms provided they meet current ULDC requirements. (BLDG PERMIT: LANDSCAPE Zoning(Previous Landscape Condition 2 of Resolution R-2006-516, Control No. 2004-525)
- 3.A group of three (3) or more palms may not supersede the requirement for a canopy tree in that location, unless specified herein. (BLDG PERMIT: LANDSCAPE Zoning) (Previous Landscape Condition 3 of Resolution R-2006-516, Control No. 2004-525)
- 4.Field adjustment of berm and plant material locations may be permitted to provide pedestrian sidewalks/bike paths and to accommodate transverse utility or drainage easements crossings and existing vegetation. (BLDG PERMIT: LANDSCAPE Zoning) (Previous Landscape Condition 4 of Resolution R-2006-516, Control No. 2004-525)
- 5.Prior to the issuance of a building permit, the property owner shall submit a Landscape Plan to the Landscape Section for review and approval. The Plan(s) shall be prepared in compliance with the conditions of approval as contained herein. (BLDG PERMIT: LANDSCAPE Zoning) (Previous Landscape Condition 5 of Resolution R-2006-516, Control No. 2004-525)

ZONING - LANDSCAPING-ALONG THE WEST PROPERTY LINE (ABUTTING FLORIDA'S TURNPIKE)

6.In addition to code requirements and the proposed planting program, the landscape buffer along the west property line shall be upgraded to include:

a. a minimum of one (1) flowering tree for each fifty (50) linear feet of the property line, to be planted on both sides of the wall or FDOT sound barrier. Flowering trees shall be spaced a maximum distance of seventy-five (75) feet on center on each side of the wall or FDOT sound barrier. (BLDG PERMIT: LANDSCAPE - Zoning) (Previous Landscape Condition 6 of Resolution R-2006-516, Control No. 2004-525)

ZONING - LANDSCAPING-COMPATIBILITY BUFFER BETWEEN PODS B AND C

7. In addition to code requirements for the required landscape buffer along the property line between pods B and C, landscaping shall be upgraded to include:

one (1) palm or pine for each for each thirty (30) linear feet of the property line with a maximum spacing of sixty (60) feet between clusters. (BLDG PERMIT: LANDSCAPE - Zoning)

ZONING - LANDSCAPING-ALONG THE EAST PROPERTY LINE OF POD C, NORTH OF THE L-33 CANAL

8.In addition to code requirements, landscaping along the east property line of Pod C (west side of E-2-E Canal) shall be upgraded to include:

- a. A continuous berm with a minimum height of one (1) foot; a maximum of one (1)-foot width of the berm may overlap into open space;
- b. A six (6) foot high vinyl coated chain link fence;
- c. A continuous hedge planted on the east side of the fence to be maintained at a minimum of six (6) feet in height;
- d. Required trees shall be native canopy trees with a maximum spacing of twenty (20) feet;
- e. One palm or pine tree for every 20 linear feet of the property line with a maximum

spacing of sixty (60) feet between clusters; and,

f. Landscape installation:

- i. The fence shall be installed concurrent with the construction of the project's spine road north of the L-33 Canal.
- ii. The landscaping within the east buffer adjacent to the projects main spine road shall be installed immediately upon completion of the roadway (if the roadway is built in sections, then the landscaping would be required to be installed adjacent to any completed section only).
- iii. The landscaping adjacent to any unit or building within Pod C-2 shall be installed prior to receipt of the first CO. (BLDG PERMIT: LANDSCAPE Zoning)

PALM TRAN

- 1. The location of an easement for a Bus Stop Boarding and Alighting Area, subject to the approval of Palm Tran shall be shown on the Preliminary Development Plan and/or final plan prior to final approval of the DRO. The purpose of this easement is for the future construction of mass transit infrastructure in a manner acceptable to Palm Tran. (DRO: PALM TRAN-Palm Tran) (Previous Mass Transit Condition 1 of Resolution R-2005-2291, Control No. 2004-525)
- 2.Prior to issuance of the first Building Permit or recordation of the plat, whichever shall first occur, the property owner shall convey and or dedicate to Palm Beach County an easement for a Bus Stop Boarding and Alighting Area in a form with terms and conditions approved by Palm Tran. Supporting documentation, including but not limited to, a location sketch, legal description, affidavit of ownership, attorney title opinion and other related documents as deemed necessary by Palm Tran. (BLDG PERMIT/PLAT: MONITORING-Eng) (Previous Mass Transit Condition 2 of Resolution R-2005-2291, Control No. 2004-525)

PLANNING

1.Planning Condition 1 of Resolution R-2006-0516, Control No. 2004-525 which currently states:

Prior to final site plan approval by the Development Review Officer (DRO), the plan shall include all pathways within and pedestrian access to the open space and recreation areas, and along lakes tracts generally consistent with the certified master plan, dated February 17, 2006. (DRO: PLANNING Planning)

Is hereby amended to read:

Prior to final site plan approval by the Development Review Officer (DRO), the plan shall include all pathways within and pedestrian access to the open space and recreation areas, and along lakes tracts generally consistent with the certified master plan, dated February 13, 2009. (DRO: PLANNING Planning)

2.Planning Condition 2 of Resolution R-2006-0516, Control No. 2004-525 which currently states:

Prior to final site plan approval by the Development Review Officer (DRO), the site plan shall indicate a pedestrian pathway fronting the lakes within the passive park areas in POD C". This pedestrian pathway shall provide continuous circulation to the sidewalks within the development. In addition, a minimum of one (1) bench shall be placed at each of these locations. (DRO: PLANNING - Planning)

Is hereby amended to read:

Prior to final site plan approval by the Development Review Officer (DRO), the site plan shall indicate a pedestrian pathway fronting the lakes within the passive park areas in POD B-2" and POD C-1". This pedestrian pathway shall provide continuous circulation to the sidewalks within the development. In addition, a minimum of one (1) bench shall be placed at each of these locations. (DRO: PLANNING - Planning)

- 3. Prior to final approval by the Development Review Officer (DRO), the property owner shall record in the public records of Palm Beach County a restrictive covenant, in a form acceptable to the Palm Beach County Attorney, which includes but is not limited to the following:
- a. Guarantees the attainability of all 71 workforce units, which includes all units required per Article 5.G in the ULDC per the time frames noted within the adopted ULDC at the time of BCC approval. These units are to be distributed among the categories (low, moderate 1, moderate 2, and middle) consistent with the Workforce Housing requirements in Article 5.G in the ULDC. (DRO: COUNTY ATTY- Planning)
- 4.Prior to final approval by the Development Review Officer (DRO), the property owner shall include a notation in Master Plans and related Site Plans that shall indicate that a minimum of 71 units have been designated as workforce housing units. Notations shall make reference to the recorded Restrictive Covenants for Workforce Housing and indicate that all the required workforce units are subject to the Restrictive Covenants and shall be sold, resold, or rented only to low, moderate 1, moderate 2, or middle-income qualified households. (DRO: PLANNING Planning)
- 5.On an annual basis, beginning April 1, 2010, or as otherwise stipulated in the Declaration of Restrictive Covenants for Workforce Housing, the property owner, master homeowners association, or property owner association shall submit an annual report to the Planning Division and HCD documenting compliance with the Declaration of Restrictive Covenants for Workforce Housing. (DATE/ONGOING: MONITORING Planning/HCD)

PLANNED UNIT DEVELOPMENT

- 1.Prior to the recordation of the first plat, all property included in the legal description of the application shall be subject to a Declaration of Restrictions and Covenants acceptable to the County Attorney's office which shall include the following:
- a. Formation of a single master property owner's association, automatic voting membership in the master association by any party holding title to any portion of the subject property, and assessment of all members of the master association for the cost of maintaining all common areas.
- b. All recreation parcels shall be deed restricted to recreation for the use of the residents of the development. At the time of turnover of the POA/HOA, the recreation parcel shall be turned over to the association at no cost to the residents.
- c. The property shall not be subject to the Declaration of Restrictions in phases. Approval of the Declaration must be obtained from the County Attorney's office prior to the recordation of the first plat for any portion of the planned development. This Declaration shall be amended when additional units are added to the PUD. (PLAT: CO ATTY Zoning(Previous PUD Condition 1 of Resolution R-2006-516, Control No. 2004-525)
 - 2.All landscape focal points shall be:
- a. subject to review and approval by the Landscape Section; and,
- b. reflected on the regulating plan prior to final approval by the Development Review Officer (DRO). (DRO: LANDSCAPE Zoning(Previous PUD Condition 2 of Resolution R-2006-516, Control No. 2004-525)
- 3.PUD Condition 3 of Resolution R-2006-516, Control No. 2004-525, which currently states:

Prior to final approval by the Development Review Officer (DRO), the site/regulating plans shall be revised to indicate a landscape focal point:

- a. within a central island of all cul-de-sacs and roundabouts:
- b. within each semi cul-de-sac/eyebrow island in Pod C; and,
- c. at the terminus of all dead-end streets. (DRO: ZONING Zoning)

Is hereby amended to read:

Prior to final approval by the Development Review Officer (DRO), the site/regulating plans shall be revised to indicate a landscape focal point within a central island of all cul-de-sacs and roundabouts. (DRO: ZONING - Zoning)

4.PUD Condition 4 of Resolution R-2006-516, Control No. 2004-525, which currently states:

Prior to final approval by the Development Review Officer (DRO), the master/site plans shall be revised to indicate a minimum of one (1) fountain as a focal feature within each lake tract. The location of each fountain shall be subject to review and approval by the Zoning Division. (DRO: ZONING - Zoning)

Is hereby deleted. [REASON: ULDC has been amended]

5.PUD Condition 5 of Resolution R-2006-516, Control No. 2004-525, which currently states:

Prior to final approval by the Development Review Officer (DRO), the site/regulating plans shall be revised to depict upgraded recreation amenities within each of neighborhood park. These additional amenities shall:

- a. be accessible from a minimum five (5) foot wide pathway composed of stamped concrete, paver blocks, or other improved surface. This pathway shall have a direct connection to the the primary sidewalk system on the property;
- b. include a minimum of two (2) pedestrian benches;
- c. include a minimum of one (1) trash receptacle adjacent to each pedestrian bench;
- d. include a shade structure (eg. trellis, gazebo, pergola, loggia, berceaux), tot lot, fitness station, rest station, or similar recreation amenity; and,
- e. be subject to review and approval by the Architectural Review Section. (DRO: ZONING Zoning)

Is hereby amended to read:

Prior to final approval by the Development Review Officer (DRO), the site/regulating plans shall be revised to depict upgraded recreation amenities within each of neighborhood park. These additional amenities shall:

- a. be accessible from a minimum five (5) foot wide pathway. This pathway shall have a direct connection to the the primary sidewalk system on the property;
- b. include a minimum of two (2) pedestrian benches; and,
- c. include a minimum of one (1) trash receptacle. (DRO: ZONING Zoning)
- 6.PUD Condition 6 of Resolution R-2006-516, Control No. 2004-525, which currently states:

Prior to final approval by the Development Review Officer (DRO), the site/regulating plans shall be revised to indicate the following amenities adjacent to the 8-foot wide asphault bike path:

- a. a minimum of one (1) pedestrian bench for each five hundred (500) linear feet of the bike path with a maximum spacing of six hundred sixty (660) feet between each bench;
- b. a minimum of one (1) trash receptacle adjacent to each pedestrian bench; and,
- c. a minimum of one (1) canopy tree spaced a maximum distance of fifty (50) feet on center, to be planted alternating on both sides of the path. These trees shall be provided in addition to required street trees. (DRO: ZONING Zoning)

Is hereby deleted. [REASON: is reconfigured]

7.PUD Condition 6 of Resolution R-2006-516, Control No. 2004-525, which currently

states:

Prior to final approval by the Development Review Officer (DRO), the site/regulating plans shall be revised to indicate the following amenities adjacent to the 5-foot wide pedestrian pathways within Pod A and the .73-acre passive park:

- a. a minimum of three (3) pedestrian bench with a maximum spacing of three hundred (300) feet between each bench;
- b. a minimum of one (1) trash receptacle adjacent to each pedestrian bench; and,
- c. a minimum of one (1) canopy tree spaced a maximum distance of forty (40) feet on center, to be planted alternating on both sides of the pathways. (DRO: ZONING Zoning)

Is hereby deleted. [REASON: Preliminary Master Plan is reconfigured]

- 8.Each townhouse unit shall include a garage with interior dimensions that excess minimum ULDC requirements for a residential parking space or a separate storage closet for trash receptacles. (BLDG PERMIT: BLDG Zoning) (Previous PUD Condition 8 of Resolution R-2006-516, Control No. 2004-525)
- 9.PUD Condition 9 of Resolution R-2006-516, Control No. 2004-525, which currently states:

Prior to final approval of a site plan for the 3.06-acre recreation pod, the Development Review Officer (DRO) shall apply and the property owner shall accept the following condition of approval:

Prior to the issuance of a building permit for the 190th unit, a Certificate of Occupancy (CO) or Certificate of Completion (CC), whichever shall first occur, shall be issued for a clubhouse or similar common building that is acceptable to the Parks and Recreation Department on the 3.06-acre recreation pod. This facility shall be equipped with a generator that complies with the following requirements:

- a. operates essential electrical systems, including A/C systems, for a minimum of thirty percent (30%) of the gross interior floor area of the building;
- b. an aboveground fuel storage system, or an alternative fuel storage system that is acceptable to Palm Beach County, with a minimum capacity that is acceptable to the Building Division shall be located adjacent to the generator;
- c. setback in accordance with the Property Development Regulations for a Recreation Pod in accordance with ULDC Table 3.E.2.D-16;
- d. screened from view on all sides by an opaque barrier constructed of compatible materials, color and character as the building or equivalent landscaping;
- e. subject to review and approval by the Building Division; and,
- f. deviation from these requirements shall be permitted if consistent with future ULDC regulations. (DRO: ZONING Zoning)

Is hereby deleted. [REASON: Code requirement]

10.PUD Condition 10 of Resolution R-2006-516, Control No. 2004-525, which currently states:

Prior to final approval by the Development Review Officer (DRO), the master and site/subdivision plan(s) shall provide for a minimum twenty (20) foot centerline offset in the general vicinity of the midpoint of each north-south roadway segment within Pod C. In the case of conflict with requirements of the County Engineer, the required offset distance may be reduced as deemed necessary by the County Engineer. (DRO: ZONING - Zoning)

Is hereby deleted. [REASON: no longer applicable]

11. Prior to final DRO approval, all multi-family units along the west side of the E-2-E canal, directly abutting the internal spine road, shall be a maximum two stories in height,

not to exceed a maximum thirty (30)-feet in height measured to the highest point of the structure. (DRO: ZONING - Zoning)

12. The owner/ developer shall provide for and maintain rodent control during land development and site construction within the project. (ONGOING: ZONING - Zoning)

SCHOOL BOARD

1. The property owner shall post a notice of annual boundary school assignments for students from this development. A sign 11" X 17" shall be posted in a clear and visible location in all sales offices and models with the following:

"NOTICE TO PARENTS OF SCHOOL AGE CHILDREN"

School age children may not be assigned to the public school closest to their residences. School Board policies regarding levels of service or other boundary policy decisions affect school boundaries. Please contact the Palm Beach County School District Boundary Office at (561) 434-8100 for the most current school assignment(s). (Previous School Board Condition 1 of Resolution R-2006-0516, Control No. 2004-525) (ONGOING: SCHOOL BOARD)

2.Prior to the issuance of the first Certificate of Occupancy (CO), the school bus shelter shall be constructed by the petitioner in a location and manner acceptable to the Palm Beach County School Board. Provisions for the bus shelter shall include, at a minimum, a covered area, continuous paved pedestrian and bicycle access from the subject property or use, to the shelter. Maintenance of the bus shelter(s) shall be the responsibility of the residential property owner. (Previous School Board Condition 2 of Resolution R-2006-0516, Control No. 2004-525) (CO: MONITORING School Board.)

COMPLIANCE

- 1. In granting this approval, the Board of County Commissioners relied upon the oral and written representations of the petitioner both on the record and as part of the application process. Deviations from or violation of these representations shall cause the approval to be presented to the Board of County Commissioners for review under the compliance condition of this approval. (ONGOING: MONITORING Zoning)
- 1. Failure to comply with any of the conditions of approval for the subject property at any time may result in:
- a. The issuance of a stop work order; the issuance of a cease and desist order; the denial or revocation of a building permit; the denial or revocation of a Certificate of Occupancy; the denial of any other permit, license or approval to any developer, owner, lessee, or user of the subject property; the revocation of any other permit, license or approval from any developer, owner, lessee, or user of the subject property; revocation of any concurrency; and/or
- a. The revocation of the Official Map Amendment, Conditional Use, Requested Use, Development Order Amendment, and/or any other zoning approval; and/or
- b. A requirement of the development to conform with the standards of the ULDC at the time of the finding of non-compliance, or the addition or modification of conditions reasonably related to the failure to comply with existing conditions; and/or
- c. Referral to code enforcement; and/or
- d. Imposition of entitlement density or intensity.

Staff may be directed by the Executive Director of PZ&B or a Code Enforcement Special Master to schedule a Status Report before the body which approved the Official Zoning Map Amendment, Conditional Use, Requested Use, Development Order Amendment, and/or other zoning approval, in accordance with the provisions of Article 2.E of the ULDC, in response to any flagrant violation and/or continued violation of any condition of approval. (ONGOING:MONITORING-Zoning)
