## RESOLUTION REVOKING RESOLUTION R-1980-377 (CONTROL NUMBER 1980-00008) AFFIRMING THE LEGISLATIVE ABANDONMENT OF ZONING APPLICATION ZV/CB/ABN-2013-01845
