RESOLUTION CORRECTING RESOLUTION R-2017-1638
(CONTROL NO. 2002-00018)
RESOLUTION APPROVING ZONING APPLICATION OF Kings Academy Inc
The King's Academy and PBC Park Site at Sansbury's Way
APPLICATION CRB-2017-02401

WHEREAS, Kings Academy Inc, petitioned the Palm Beach County Board of County Commissioners on October 26, 2017 for a Development Order Amendment to reconfigure the Master Plan; and add land area, square footage; and an access point;

WHEREAS, Resolution No. R-2017-1638, adopted on October 26, 2017 confirming the action of the Board of County Commissioners inadvertently contained errors in Exhibit C; and

WHEREAS, ZONING Condition – LIGHTING-7 and USE LIMITATION-8 of Exhibit C of Resolution R-2017-1638 should have read as shown as follows:

LIGHTING

7. The re-designated 4.98-acre parcel (Tract C) shall be limited to an un-lighted sports practice field with the exception to security and indoor lighting for the accessory structure. (ONGOING: ZONING – Zoning)

USE LIMITATION

8. The re-designated 4.98-acre parcel (Tract C) shall be limited to an un-lighted sports practice field and the accessory structure. (ONGOING: ZONING – Zoning)

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

1. The foregoing recitals are hereby affirmed and ratified.
2. ZONING Condition – LIGHTING-7 and USE LIMITATION-8 of Exhibit C of Resolution R-2017-1638 are hereby corrected.

Commissioner Burdick moved for the approval of the Resolution.
