WHEREAS, the Declarant and the Board desire to modify and amend the Covenant as hereinafter set forth.

NOW, THEREFORE, Declarant and the Board hereby declare that the Covenant is hereby amended as follows:

1. The recitations set forth herein above are true and correct and are incorporated herein by reference. Unless otherwise defined herein, each initial capitalized term used in this Amendment shall have the meaning given to such term as set forth in the Covenant.

2. Utility Allowance Section 6 is hereby deleted in its entirety.

3. This Amendment shall become effective upon the execution by the parties hereto and recording amongst the Public Records of Palm Beach County, Florida.

4. Except as modified by this Amendment, the Covenant shall remain in full force and effect in accordance with the terms thereof. In the event any of the provisions of this Amendment shall be deemed invalid by a court of competent jurisdiction, said judicial determination shall in no way affect any of the other provisions hereof or of the Covenant, which shall remain in full force and effect, and any provisions of this Amendment deemed invalid by a court of competent jurisdiction by virtue of the term or scope thereof shall be deemed limited to the maximum term and scope permitted by law.
