1. Prior to the issuance of the first Certificate of Completion or Occupancy, whichever occurs first, the Property Owner shall provide the Zoning Division with proof that the water and sewer lines have been constructed and installed to the east property line. The extension of the lines shall be provided in the northern drive way where the emergency fire rescue exit is proposed. (BLDGPMT/CO: ZONING - Zoning)

WHEREAS, all other Conditions of Approval contained within Exhibit C of Resolution R-2025-1587 remain in effect;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

- 1. The foregoing recitals are true and correct, and are incorporated herein.
