

RESOLUTION RATIFYING RESOLUTIONS  
APPROVING PALM BEACH COUNTY ZONING  
RESOLUTION NO. 3-57, AS AMENDED, AND  
APPOINTING MEMBERS TO PALM BEACH  
COUNTY ZONING COMMISSION

WHEREAS, on January 19, 1971, the Board of County Commissioners of Palm Beach County, Florida adopted a Resolution approving Palm Beach County Zoning Resolution No. 3-57, adopted May 13, 1957, as amended by the Palm Beach County Zoning Commission through August 6, 1970, and enacting said Resolution as amended as the Palm Beach County Zoning Resolution under which the Board of County Commissioners shall exercise zoning powers pursuant to Chapter 31119, Laws of Florida, 1955, Chapter 57-1691, Laws of Florida, 1957, and Chapter 59-1686, Laws of Florida, 1959, which is on file with the Clerk of this Board; and

WHEREAS, on January 26, 1971, this Board passed a Resolution appointing members to the Palm Beach County Zoning Commission, which resolution is on file with the Clerk of this Board; and

WHEREAS, Chapter 70-683, Laws of Florida, 1970, takes effect on February 1, 1971, and this Board wishes to ratify its actions in adopting the above resolutions to provide continuity in the transfer of zoning authority from the Zoning Commission to this Board;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that this Board ratifies its actions previously taken in passing and adopting the aforesaid resolutions, and such resolutions are hereby re-enacted, adopted and affirmed as if each such resolution was fully set forth herein.


