ZONING RESOLUTION NO. 3-I-71 CONFIRMING THE MODIFICATION OF THE DISTRICT BOUNDARIES PURSUANT TO ACTION OF THE BOARD FEBRUARY 25, 1971

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, in regular session assembled this the 19th day of March, 1971, that the action of the Board of County Commissioners in session on February 25, 1971, modifying the district boundaries, as follows, is hereby confirmed:

Tracts 38 and 43, Florida Fruit Lands Company's Subdivision No. 2 of Section 25, Township 47 South, Range 41 East as recorded in Plat Book 1, Page 102; also a parcel of land in Sections 25, 26, 35 and 36, Township 47 South, Range 41 East, being more particularly described as follows: beginning at the northeast corner of Tract 42 of Florida Fruit Lands Company's Subdivision of Section 25, Township 47 South, Range 41 East, as recorded in Plat Book 1, Page 102; thence southerly along the east line of said Tract 42, (the east line of Tract 42 is assumed to bear South 0° 14' 26" West and all other bearings herein are relative thereto) South 0° 14' 26" West, a distance of 230.5 feet; thence South 89° 45' 34" East a distance of 25.00 feet; thence South 52° 00' 00" West, a distance of 172.32 feet; thence North 38° 00' 00" West, a distance of 55. 00 feet; thence South 52° 00' 00" West, a distance of 92. 00 feet; thence South 16° 20' 57" West, a distance of 163. 60 feet to an intersection radially with a curve concave to the southwest, having a radius of 720 feet and a central angle of 35° 39' 03"; thence southeasterly along the arc of said curve, a distance of 448.00 feet to a point of tangency; thence South 38° 00' 00" East, a distance of 290, 00 feet; thence South 520 00' 00" West, a distance of 255.00 feet; thence South 10 07' 48" East, a distance of 130.00 feet; thence South 20° 01' 06" West, a distance of 31.94 feet; thence South 1° 00' 00" West, a distance of 90 feet to an intersection radially with a curve concave to the north having a radius of 400.00 feet and a central angle of 3° 27' 53"; thence westerly along the arc of said curve, a distance of 24.19 feet; thence South 190 22' 37" West, a distance of 396 feet, more or less, to the north right-of-way line of the Hillsboro Canal; thence westerly along the north right-of-way line of the Hillsboro Canal, to the west line of said Section 36; thence continue westerly 68.8 feet, more or less, to the easterly right-of-way line of a 140 foot wide Florida Power & Light Company casement; thence

northerly along the East line of the Florida Power & Light Company easement to the North line of Section 35; thence easterly along the North line of Section 35 and along the said Florida Power & Light Company easement a distance of 15 feet; thence northerly along the East line of said Power Company easement, a distance of 990.3 feet, more or less, to the North line of the South 30 acres of the East 1/4 of Section 26; thence easterly along said North line, a distance of 50 feet, more or less, to the East line of said Section 26; thence northerly along said East line, a distance of 5.29 feet, more or less, to. the westerly extension of the North line of Tract 43 of aforesaid Florida Fruit Lands Company's Subdivision; thence easterly along the said westerly extension, a distance of 15 feet, more or less, to the West line of said Tract 43; thence southerly along the West line of said Tract 43 to the Northwest corner of Tract 42 of said Florida Fruit Lands Company's Subdivision; thence easterly along the North line of Tract 42 to the Northeast corner of said Tract 42 and the point of beginning is hereby rezoned from A-1 Agricultural District to R-2 Multiple Family Dwelling District.

BE IT FURTHER RESOLVED, that Zoning Resolution No. 3 be amended accordingly pursuant to Chapter 57-1691, Special Laws of Florida 1957, and Chapter 59-1686, Special Laws of Florida, 1959, Chapter 70-863, Special Laws of Florida, 1970.
