**I. CALL TO ORDER**

## **II. Approval of Meeting Minutes**

A motion was made to approve the 4-20-17 meeting minutes as presented by Dave Stewart and seconded by Harry Raucher. The motion passed unanimously.

## **III. Meeting Dates For 2018 Ken Todd, PBC Water Resource Manager**

Ken Todd presented two sets of meeting dates for consideration by the WRTF for the coming year (2018). The first set was for dates that tract the established months the WRTF has historically met. The second set revised the months the WRTF would meet to help with vacation schedules. Paulette Burdick requested the WRTF keep the historical month schedule and all agreed. ## **V. Legislative Update Chris Pettit, PBC Water Utilities**

Chris Pettit made a presentation that updated the legislative activities of the Florida Legislature for this past legislative session, specifically those bills that dealt with water issues.

## **VII. LRWRP Update Beth Kacvinsky, SFWMD**

Beth Kacvinsky provided an update of the Loxahatchee River Watershed Restoration Project. Beth indicated that the modeling sub-team SFWMD was working to address concerns based on recent modeling results and as a result the Scheduled has slipped. She indicated that the Project team hoped to have a schedule update by the end of the month. She said the modeling team has modeled five alternatives and are developing three hybrids. The team is continuing refine project costs and water quality analyses for each alternative. Beth was asked when a Tentatively Selected Plan (TSP) would be recommended to Corps headquarters. Beth thought it would probably be sometime early next year. Once the TSP is selected, it would have to go through a review process in the Corps' chain of command and that would take about a year.

## **IX. FEMA Map Update Doug Wise, PBC Building Dept.**

Doug Wise provided an update on the FEMA Maps and explained how they are utilized by the Building Department. Doug indicated that FEMA, on April 5, 2017, sent out a Letter of Final Determination. However, the County and the municipalities did not received the maps until July 2, 2017. The maps will take effect on October 5, 2017.

Doug then gave a brief explanation of how the Building Departments utilize the maps during the review of building permits. He explained several concepts that are addressed as part of their review: lowest floor, substantial improvement and substantial damage. If the existing building has had an improvement of more than 50% cost than the entire building must be brought up to current code. The same concept applies to repairs to a house from flood damage. He provided some real life examples to help explain the concepts.

He finished his presentation by letting all know that the maps are substantially better than they were in 2000 when first sent to the governmental entities and from the 2014 version of the maps after FEMA had redone them in their map modernization process. He said this was due mainly because of the work done by all in providing better information to FEMA during the map modernization process. He noted, although the maps are much better now, they still are not perfect. County staff has identified about six areas within the unincorporated area of PBC that they will be working with FEMA to improve the maps for those areas.

Drew Martin commented that discharging water from Lake Okeechobee into the C-51 Reservoir would affect the water quality for the surrounding water bodies. He said he would like the Task Force to look into Water Quality issues in addition to water quantity issues.
