HB 7053 - Statewide Flooding and Sea Level Rise Resilience

Establishes the Statewide Office of Resilience within the Executive Office of the Governor, and authorizes the use of Resilient Florida Grant Program funds to fund preconstruction activities for Statewide Flooding and Sea-Level Rise Resilience Plan.

SB 494 - Fish and Wildlife Conservation Commission

Specifies that a vessel is at risk of becoming derelict if it is tied to an unlawful or unpermitted mooring or other structure.

HB 1475 - Cleanup of Perfluoroalkyl and Polyfluoroalkyl Substances Establishes levels for PFAS in drinking water.

SB 1078 - Soil and Water Conservation Districts
Candidates must be in agriculture industry.

SB 1326 / HB 513 - Comprehensive Review Study of the Central and Southern Florida Project

Requires SFWMD to prepare and submit a consolidated annual report on the status of the ACOE C&SF Restudy.

SB 882 - Inventories of Critical Wetlands

Requires each water management district governing board to develop a list of critical wetlands for acquisition using funds from Land Acquisition Trust Fund.

SB 2508 - Environmental Resources

This budget conforming bill:

- Authorizes the Department of Environmental Protection to enter into agreements with public entities to expedite evaluation of environmental resource permits.
- Requires water shortages within the Lake Okeechobee Region to be managed pursuant to Rules 40E-21 and 40E-22 and provides that any changes to such rules may not take effect until ratified by the Legislature and presented to the Governor.
