The Conference was held virtually via Zoom on Wednesday, March 17, 2021 at 10:00 a.m. A proposer that did not attend the conference, must view the entire recording of the mandatory pre-proposal conference which is available on the YSD website under a tab titled "Notice of Funding Opportunity" at www.pbcgov.com/youthservices/Pages/NOFO.aspx</p>	
Q4.	<p>Is there a way for multiple users from one agency to share access to the NOFO dashboard, so we can work on it individually with our own logins?</p>	3/17/2021
A4.	<p>The NOFO Dashboard is not designed for multiple users from one agency to share access and work on it individually to complete a proposal.</p>	
Q5.	<p>Thank you for hosting the informative call this morning. During the call Tammy Fields stated that agencies that do not have audited financials can not apply for the NOFO. However I am writing to get clarify. Do you require a certain number of years for an audit in order to apply, or just one? Our agency received core accreditation from Nonprofits First. Because we are a smaller agency without audited financials, NPF was more arduous regarding our financial policies and procedures and can attest to this independently. Also are there exceptions for non audited agencies based on the length of time in existence? In 2019, our agency met with several representatives in Youth Services to discuss our programming goals and to see how we could collaborate. At the time, we were told that because our agency was less than three years old, we could not apply for funding. Now that we are over three years old, we are being told that we need audited financials. I look forward to seeing if smaller and newer agencies will have the opportunity to participate in the NOFO with the hopes of creating a more equitable landscape. Thank you for your consideration.</p>	
A5.	<p>Pursuant to Section VI.3.7.5 of the NOFO all agencies are to upload a copy of their most recent audit report. Only one is required. However, pursuant to Section VI.3, if the agency is certified by Non-Profits First, an agency can upload their certification and they do not need to upload an Independent Audit. It should be noted, that if Agency is selected for award and contracts with Palm Beach County, annual Independent Financial Audits will be required throughout the term of the contract.</p>

- Q9. Will this be recorded?** 3/17/2021

- Q11. So YSD is looking for proposals to address provision of this type of training to frontline professionals?** 3/17/2021
- A11.** The answer is 'yes'. We do expect that all our agencies will have training provided in the areas mentioned in the RFP.
- Q12. Can you apply for more than one category? By submitting multiple applications?** 3/17/2021
- A12.** Yes, it is recommended you don't submit the exact same application in more than one category, but an agency may have different programs within the agency and you may submit more than one application in more than one category.
- Q13. Is there a character/word limit for each of the questions?** 3/17/2021
- A13.** No limit, but recommend that agency's be to the point and concise., but fully explain the answers. Volunteer reviewers need to be able to fully understand the proposal.
- Q14. Is there a limit to the budget?** 3/17/2021
- A14.** No limit, but keep in mind under this RFP, there is only 1.3 million dollars available. YSD is looking for concise budget, and hope that agencies have other funding sources. Be reasonable in your budgets and be prepared to explain what your agency would do if it did not receive the full request.

A15.	This information is included in the Budget Worksheet Template. Admin costs are those that support the entire agency/organization, not only the funded program.	
Q16.	Can agencies that do not conduct an annual audit still apply?	3/17/2021
A16.	For this particular NOFO, the answer is 'no'. Agencies must have an audit in order to apply. For further clarification see A5 above.	
Q17.	What if we don't have audited financials? We do have a 990 prepared by a CPA FY 2020. Will that suffice?	3/17/2021
A17.	Unfortunately, no. Financial audit needed in order to apply. For further clarification is A5 above.	
Q18.	How do we access the link to register? Will the link be sent to those who attended the meeting today?	3/17/2021
A18.	Visit the County's on-line Vendor Self Service system at https://pbcvssp.co.palm-beach.fl.us/webapp/vssp/AltSelfService .	
Q19.	How long does it take from application submission to approval?	3/17/2021
A19.	Slide 15 of the Presentation indicates the NOFO timeline. Applications due April 12; Review Panels meet April 16-30, and May 11 YSD will post recommended awards. The recommendations will go to the Board of County Commissioners (BCC). No BCC date has been selected at this time. Every agency that submits an application will receive notice of when the recommendations will go to the BCC.	
Q20.	Are the Action Areas ranked in any way? In order of priority to the County? Is funding allocated equally among the Action Areas?	3/17/2021
A20.	No, to both. YSD has not ranked the action areas. All areas are priorities established under the Youth Master Plan. As far as how much will go to each area, it will depend on the quality of the applications received, the number of applications and how we can best meet the needs with the dollars we have available.	
Q21.	Should start date/end date be 10/1/2021 - 9/30/2024 though the budget only reflects one year?	3/17/2021
A21.	The start date and end dates should be one-year. The contract will be for three years, but all of the review will be based on a one-year snapshot.

Q23. Will there be geographical prioritization for awards?	3/17/2021
A23. Slide 18, Proposal Highlights - geography is going to be an element of consideration in the Description of Need and in the Local Data that is provided to YSD. Slide 19, Priority Area Score - as previously explained. Often times when the review panels do their priority area score, if they see a geographic area that has a low level of services currently available, they will rank that higher, so although YSD does not have a specific geographical preference, it is a consideration in several areas.	
Q24. Is there a best practice in terms of percentage/amount requested vs. the agency overall budget?	3/17/2021
A24. The agency cannot request more than 25% of their overall budget from YSD funding.	
Q25. Do you have a sense of how many awards you expect to make? Is the 25% of County funding refer to all county contracts or just this one?	3/17/2021
A25. No. It will depend on the quality of the applications, and the needs that YSD is seeing compared to the amount of funding that is available. As for the 25% it will refer to all contracts with YSD. YSD will not fund more than 25% of your agency.

A26 Currently, AVDA's contract with Palm Beach County (through Youth Services) is for the term October 1, 2020 through September 30, 2022. The NOFO released on March 15, 2021 is for the Community Based Agency program for Fiscal Years (FY) 2022-2024 (October 1, 2021–September 30, 2024). Contracts issued will be for one (1) three (3) year period. It is AVDA's decision whether or not to apply for opportunities.
