#### **Purpose**:

The Summer Food Service Program (SFSP) provides meals and snacks to low-income school aged children during the summer months (June-August).

Palm Beach County Youth Services Department – Outreach and Community Programming Division (OCP) acts as the sponsor, which entails administration and monitoring of the SFSP funded by the United States Department of Agriculture (USDA) and administered by the Florida Department of Agriculture and Consumer Services (FDACS).

Sponsors enter into agreements with sites to receive vended cold meals daily or shelf-stable meals weekly. Eligible sites within the community receive and serve meals in a safe and supervised setting. Sites are located within five miles of a school with at least 50% free or reduced lunch.

#### Summer Food Monitors:

Summer Food monitors are employed to assist with trainings of food sites, complete paperwork, and monitor assigned sites in compliance with USDA requirements.

Monitors are college students, who are provided structure and training, giving them exposure to the workforce and developing teamwork, leadership and effective communication skills.

The summer of 2021 saw the beginning of a rebound in available sites after the sharp decline in 2020 due to the COVID-19 pandemic and the unavailability of sites.




#### Percent Change from Previous Year






#### Percent Change from Previous Year

June consisted of eight (8) service days; July had 21 service days; and August served a total of five (5) days.










#### Servings by District:



The most meals were served in District 7.









#### Types of Sites:

The majority of feeding sites consisted of parks & recreation, library, and other (which included community centers, dance studios, non-profit organizations, and more).











#### Age Groups Served:

#### Shelf-Stable Feeding:

For the second year in a row, the SFSP utilized the USDA waivers related to the COVID-19 pandemic and offered shelf-stable meal kits at many locations.

The Palm Beach County Library System partnership continued with meal service at 15 library locations.



#### Waivers utilized (from FDACS & USDA):

- To serve seven days' worth of meals at one time.
- Non-Congregate Feeding Do not have to eat meals on site.
- Parents can pick up meals without children present.

#### New in 2021: Mobile Feeding Sites

- SFSP monitors were trained as site supervisors to facilitate the first year of mobile feeding with five locations throughout Palm Beach County.
- These mobile locations allowed parents to utilize the Grab 'n Go feeding style; picking up 14 meals at one time (seven days' worth of breakfast and lunch).

#### Purpose:

The Summer Camp Scholarship Program (SCSP) provides full-tuition and fees for summer camp for children residing in families with income at or below 150% of Federal Poverty Guidelines or meet priority criteria (foster-care, homeless or involvement with the delinquency systems).

Funding for the SCSP is provided through a partnership between the Palm Beach County Board of County Commissioners and the Children's Services Council. Friends of Youth Services and Palm Beach County, Inc. serves as the fiscal agent responsible for managing funds and retaining financial records.

#### Program Summary:

SCSP pays full tuition and associated fees (including field trips) for eligible children to attend day camp during the summer months. Camps across Palm Beach County are encouraged to apply to be a Summer Camp Scholarship site and offer educational, recreational, and other programming to meet the needs of Palm Beach County children.

#### Database Application:

With the implementation of the SCSP database application, the number of applications for scholarships has increased. In the years prior to 2018, all applications were in a paper format and parents were required to apply in person. Through technology, the application is accessible from any computer or mobile device. Parents still have the option to come into the Palm Beach County Youth Services Department's main office to complete their application and receive assistance from SCSP staff, or take advantage of outreach opportunities within the community. The easy online access provided by the database application has proven to be successful as measured by the increased number of applications and the decrease in outreach attendance.

#### New in 2021: Provider Presentations

New to the 2021 provider application process was the Provider Presentation. Providers had 20 minutes to present their program to YSD staff.

If a camp did not meet the requirements, they were provided technical assistance or connections to additional resources.

In addition to the camp directory which shows contact information and dates/times of operation, parents can now get a more complete picture of the services the camp offers. The most common areas needing improvement included character building/ social emotional support, preventing the summer slide, and staff growth and development.

Camps were linked to Prime Time for training and Expanded Learning Opportunities, or given free curriculum to help get them to the level the team felt was appropriate to meet the needs of campers.



- Tracking scholarships awarded versus scholarship utilized began with the creation of the database.







#### Camp Reimbursement:

Special Needs Camps = \$350 per camper per week



The L.I.T. (Liberating Inspirational Transformative) Summer Curriculum was created by the School District of Palm Beach County's Teaching and Learning Division Office of African, African American, Latino, Holocaust, and Gender Studies. It provides free content that consists of culturally relevant activities for participants in grades 6 - 8. Although the curriculum is aimed at the secondary grades, it also provides resources for primary grades K – 5. The goal of the program is to engage and inspire students through movement, art, music, and real-world experiences. All camps were encouraged to participate in this program.

#### Scholastic LitCamp Pilot Program

Scholastic's LitCamp is a literacy program appropriate for all Regular and Specialty Camps. It provides a curriculum for teachers/counselors and a library of over 250 books that camps can keep and reuse. It is comprised of "bunks" providing curriculum and books based on a campers grade level. LitCamp provides the one-hour of daily summer reading that is suggested by the School District of Palm Beach County, as well as songs, reading comprehension activities, and discussion topics. Funding for this program was provided by Friends of Youth Services.



Held on July 21, 2021, this virtual event utilized Kahoot!, a virtual learning-based platform that tested campers on spelling skills through identifying the correct spelling of a spoken word, filling in the blanks, listening and typing the correct spelling of a word, and selecting the correct word in a sentence. The spelling bee provides academic activities to encourage the spirit of learning while preventing summer and COVID slides. The top three winners from each grade category were awarded trophies and a book; the 1st place winner of each category received a Kindle.

#### Outcomes

- (75%) of ELOs, OST staff reported perceptions of youth engagement that average at least 7 out of 10 or at least 3 out of 5, depending on the rating scale for the question. Results from this Adult Perceptions of Youth Engagement Survey indicated that youth were cognitively, socially, and emotionally engaged by the activity.
- (75%) of ELOs, OST practitioners on average reported high satisfaction with the provider (giving average rating of at least eight on the Prime Time Customer Impact Survey; scale is 1 to 10, with 1 as "Not at all True" and 10 as "Very True").
- (100%) of expanded learning opportunity providers received a modified, exploratory quality assessment using the ELO Observation Feedback and Coaching Tool. The tool is designed to assess live virtual sessions and emphasizes social and emotional dimensions of quality. Providers received coaching responsive to the strengths and growth areas indicated by their assessments.
