Agenda Item: 3.E. FAA RFP Update (Meghan Parnell)

- Meghan Parnell introduced herself in her new role as Manager of Planning and Evaluation.
- Ms. Parnell briefly discussed the draft RFP document and the timeline.
- Ms. Parnell added that FAA is still looking for panel reviewers from the CAC; Elizabeth Hernandez Cayson expressed interest in Domestic Violence and Barbara Jacobowitz expressed interest in Homelessness.
- Taruna Malhotra noted that the number of proposals could not be estimated until after the mandatory Bidder's Conference. There is also a new Grievance Form attached to the Guidance document.
- Ms. Malhotra also added that program outcomes must align with the RFP Guidance priorities. Priorities will also guide the proposal rankings.
- Ms. Malhotra noted that dating violence and ages would be included in the guidelines under Domestic Violence; for Homelessness, there are currently no agencies serving unaccompanied youth due to legal complications.
- There was general discussion about further defining "Homelessness", the general restructuring of the application, considerations on changes to outcomes for Domestic Violence, and streamlining processes across the department and other organizations.

 approved.
