FAA Communications

Thank you to all of our Financially Assisted Agencies (FAA) for serving our community during this challenging time. We would like to take this opportunity to communicate some changes and plans to the FAA funding and structuring.

Extension of Contracts

As many of you are aware, we have yet to release a Notice of Funding Opportunity (NOFO) for this year. The scheduled NOFO would have been for Behavioral Health and included a funding line for Special Needs agencies. Due to various system changes and planning efforts, we have decided not to release a NOFO for this year. All current Behavioral Health contracts will be recommended for a new contract for one year, beginning October 1, 2020 through September 30, 2021. We anticipate using the remainder of the year to further plan system changes as guided by the Behavioral Health Needs assessment. A new NOFO addressing the system shifts to better serve the community in a coordinated way will be released in January of 2021.

Alignment of Funding Categories

Over the last year, we have been working towards having three service categories: Homelessness, Behavioral Health and Economic Stability. Each of these three (3) categories align with the Board of County Commissioners' (BCC) Priorities. Each of the three (3) categories would have a funding line for sub populations of Seniors, Special Needs and Domestic Violence (in Homelessness only).

In July of 2019, the Special Needs agencies were called together to further explain and outline these shifts in the funding categories. Meetings were conducted in January of 2020 to review each of the Special Needs contracts to ensure they have been identified correctly under each category.

All current Special Needs agencies will receive extensions of their contracts to align them with their new funding categories.

The category known as Non-Compete has been renamed Strategic Partnerships. These contracts will remain under this category with no changes.

A summary of the scheduled contract extensions is attached. These will be included in the funding recommendations that are provided to the Citizens Advisory Committee on Health and Human Services (CAC/HHS) and to the BCC.

New CSD structure related to NOFO Categories

In relation to the funding category alignment to the BCC Priorities, we have changed our structure to the internal NOFO process. Each FAA category will be overseen by the varying divisions of Community Services with expertise in that category. The NOFO will be overseen by that division and you will begin to see communication from those divisions in relation to that category. Contacts for each NOFO category will shift to the following:

Homelessness/Domestic Violence – Division of Human and Veteran Services, Wendy Tippett

Behavioral Health- Office of Behavioral Health and Substance Use Disorders, John Hulick

Economic Stability – Community Action Program, Natalie Diaz

In addition to the release of the NOFO shifting to these offices, there have been efforts to ensure subject matter experts are part of the contract and monitoring team overseen by Amalia Hernandez.

James Green, Community Services Director, along with Taruna Malhotra, Assistant Director, and Meghan Parnell, Manager of Planning and Evaluation, will still maintain general oversight over the long-term planning and coordinating of FAA funds. This includes ensuring that the CAC/HHS is involved as an advisory board providing input into the process. FAA funding will still be a separate line item under the Community Services budget.

Thomas Eaton, Fiscal Manager, and Julie Dowe, Finance Director, will continue to provide fiscal oversight over the FAA funds.

Technological Enhancements

We continue to enhance our electronic NOFO system by adding a centralized/consolidating monitoring and contracting module to the system. Currently the system allows for an electronic application for our FAA funding. In the future, the system will move forward the funded applications to a contract module and then finally a module where contracts will be monitored in a centralized manner.

Next Steps

The FAA funding recommendations that include the schedule for contract extensions will be presented to the CAC/HHS board at the next CAC/HHS meeting on June 11, 2020.

After the CAC/HHS provides input on these recommendations, they will be presented to the BCC during the July 14, 2020 meeting.

You can expect Amalia Hernandez, Contract Manager, to contact the Behavioral Health and Special Needs agencies regarding new contract amendments.

John Hulick, Senior Program Manager for the Office of Behavioral Health and Substance Use Disorders, and his staff will also be reaching out to you to introduce themselves and further converse about the future NOFO taking place for Behavioral Health and other related matters.
