  - A. The CJC welcomes the following new members:
    - Commissioner Priscilla Taylor to complete Commissioner Marcus’ term
    - John McKenna from the Drug Enforcement Administration replacing Luis Perez who is now in Columbia
    - Nellie L. King replacing Flynn Bertisch from the Criminal Defense Lawyers Association
  - B. Mr. Max Davis and Commissioner Karen Marcus resigned from the Criminal Justice Commission during the summer break.
- VII. Executive Director’s Comments**
  - A. The (CJC) was awarded a \$750,000 grant by the Office of Justice Programs at the Department of Justice, to expand re-entry efforts in Palm Beach County (*Media Advisory included in final agenda packet on green paper*).
  - B. CJC also received a grant award of \$324,901 from the Department of Justice for an eighteen month period to enhance their existing community-based, comprehensive anti-gang strategy. The prevention and intervention component, youth empowerment centers (YECs), are located in hotspot areas (ranking 1, 2, 4, 7, 8 in delinquency referrals) within the county and will be enhanced with targeted outreach and case management to mirror the Boys and Girls Clubs Gang Prevention

through targeted outreach. All grant funds will be subcontracted to the five partnering cities: West Palm Beach, Riviera Beach, Lake Worth, Boynton Beach and Belle Glade (*Project Abstract included in final agenda packet on salmon paper*).

- C. The Executive Committee has approved a recommendation from the Corrections Task Force/Public Safety Coordinating Council to implement a Misdemeanor Book and Release Program at the county jail.
- D. The CJC hosted the 2010 Florida Reentry Summit at the Hilton Palm Beach Airport, 150 Australian Avenue, West Palm Beach on Tuesday, September 21, 2010.
- E. During the month of July, two staff members left the CJC; Wayne English accepted the County's early retirement option and Journey Beard is now the Director of Contract Development and Quality Control for the Housing and Community Development department.
- F. The CJC has requested a grant extension to continue operation of the Community Justice Service Center (CJSC) using unexpended funds of approximately \$80,000 from the AARA JAG grant.
