- B. The CJC is hosting an Aggression Replacement Training for juvenile reentry and prevention providers/ trainers during the course of this week. Aggression Replacement Training® (ART®) is an evidenced based program that concentrates on development of individual competencies to address various emotional and social aspects that contribute to aggressive behavior in youths. Program techniques are designed to teach youths how to control their angry impulses and take perspectives other than their own. The main goal is to reduce aggression and violence among youths by providing them with opportunities to learn prosocial skills in place of aggressive behavior. The cost benefits of this training to youth in

state institutions is \$37.19 for every \$1 spent on the program, and for youth on probation is \$22.94 for every \$1 spent. Shahzia Jackson is coordinating the training.
