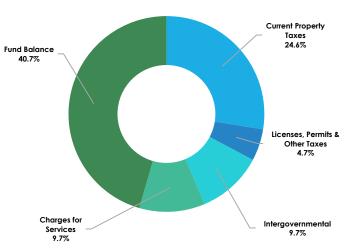

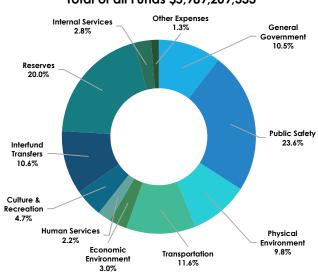

Intergovernmental revenue consists of revenues received from other government agencies. The majority of these revenues consist of Federal Grants, State Grants, and the local share of the State Sales Tax, which when combined represent 59.8% of the category. The increase in Fund Balance is primarily related to future planning within the General Fund and the carry forward of funding for previously budgeted capital projects.

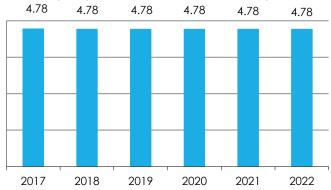
Significant changes in General Government is primarily due to funding the Supervisor of Elections Production Facility and a budgeted increase in Infrastructure Surtax Projects. The increase Physical Environment is primarily due to planned Water and Sewer capital improvement projects. The increase in Economic Environment is primarily due to carry forward of funding in the Workforce Housing Trust Fund and an increase in budgeted tourism development activities



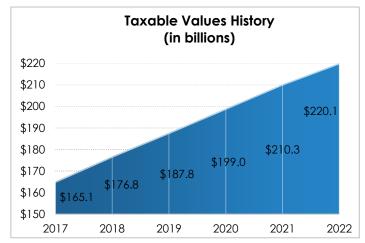

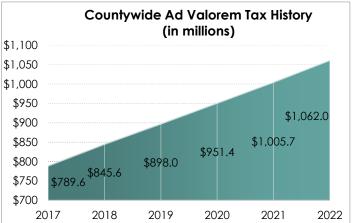

The Palm Beach County Board of County Commissioners approved a budget with a property tax rate of 4.7815 per \$1,000 of taxable value, which is 0.1898 above the calculated rollback rate. Florida Statutes limit the countywide millage rate to a maximum of 10 mills, excluding voter approved debt service millage rates.

For the FY 2022 budget, County departments were directed to submit budgets with service levels status quo with additional requests for critical needs. The Sheriff's budget is funded at \$788,630,950. The Sheriff submitted a request for a carry forward of funds totaling \$15,220,178 for equipment that did not arrive in FY 2021.

The review and adoption of the annual budget is one of the most important policy-making responsibilities of the BCC. The BCC held a retreat in December 2020 and adopted six strategic priorities to govern its strategic planning efforts. The priorities are: Economic Development, Housing and Homelessness, Environmental Protection, Infrastructure, Public Safety, and Substance Use and Behavioral Disorders. This budget reflects the BCC's commitment of continuing to enhance the quality of life in Palm Beach County.

The budget includes \$41.0 million in new Ad Valorem funded capital projects. This reflects \$18.4 million for repair and renovation of County buildings, \$9.8 million for Information Technology Systems projects, \$5 million for Parks & Recreation, \$7 million for roadway improvements, \$0.3 million for environmental restoration, and \$0.5 million for other miscellaneous projects. Additionally, Airports and Water Utilities capital projects are funded by bonds and impact fees.

A total of 12,504 positions are included in the FY 2022 budget: BCC 6,844; Sheriff 4,376; Tax Collector 339; Property Appraiser 238; Clerk & Comptroller 151; Supervisor of Elections 65, and Judicial 41.
