What Do You Need To Do?

To Receive Email Notifications of County Solicitations:

1. Activate your existing Vendor registration or register as a County Vendor by visiting: <u>https://pbcvssp.co.palm-beach.fl.us/webapp/vssp/AltSelfService</u>

(If you have already activated your vendor registration account or registered as a vendor, please use the link and proceed to Step 2)

2. Verify that your vendor account information is correct:

- a. Legal Name of Vendor AND the Vendor's TIN Number
- b. Vendor Address and Contact Information
- c. E-Mail address listed under contact information

Email address is very important to receive notifications of solicitations

3. Designate the *commodity codes* of the goods and/or services you provide.

****This is very important since the E-mail notifications you receive are based upon the commodity codes you select**** (See listing of the commodity codes most relevant to construction contractors and consultants on the reverse side of this sheet.)

4. You must submit your most recent W-9.

This is required in order to be a vendor with Palm Beach County.

Email alerts for construction business opportunities begin July 31, 2017! So, update your vendor registration account <u>now</u> to take advantage of this new resource. Email alerts for non-construction business opportunities are live now.

COMMODITY CODES RELEVANT TO CONSTRUCTION CONTRACTORS AND DESIGN CONSULTANTS

Why are commodity codes important?

When you register as a County Vendor (or update your existing registration) you will be asked to select the *commodity codes* that best describe the goods and/or services you provide. This is very important since the E-mail notifications you receive about County business opportunities are based upon the commodity codes you select.
