

RESOLUTION NO. R- 2015-0572

A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, AMENDING RESOLUTION NO. 2013-1470 TO AMEND THE LIST OF CRITICAL FACILITIES; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the Board of County Commissioners of Palm Beach County adopted resolution (Resolution R-2013-1470) finding certain facilities or areas owned, operated or leased by Palm Beach County to be critical to public safety or security pursuant to the Palm Beach County Criminal History Record Check Ordinance (Resolution R-2003-030) and Section 125.5801, Florida Statutes, with an effective date of October 22, 2013; and

WHEREAS, the Palm Beach County Board of County Commissioners desires to amend Resolution R-2013-1470 to remove Head Start Facilities from the list of Critical Facilities; and

WHEREAS, the Palm Beach County Board of County Commissioners desires to amend Resolution R-2013-1470 to add Senior Center facilities to the list of Critical Facilities.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

Section 1. Exhibit A.

Exhibit "A" of Resolution No. R-2013-1470 is hereby amended by deleting Head Start facilities.

Section 2. Exhibit A.

Exhibit "A" of Resolution No. R-2013-1470 is hereby supplemented by adding the North County, Mid County and West County Senior Centers. Exhibit "A", as amended, is attached hereto and incorporated herein by reference.

Section 3. Severability.

If any section, paragraph, sentence, clause, phrase, or word of this Resolution is for any reason held by a court to be unconstitutional, inoperative, or void, such holding shall not affect the remainder of this Resolution.
