Dear Mr. MacGillis,

As you are aware, at the request of District 6 County Commissioner Melissa McKinlay, Palm Beach West Associates I, LLLP, requested postponement of the above referenced zoning petition to the April 6, 2017, Zoning Commission (ZC) and the April 27, 2017, Board of County Commission (BCC) public hearings. This postponement was to allow the BCC to take final action on the lota Carol/Delray Linton Groves (lota/Delray) Land Use Plan Amendment application (LUPA) well in advance of the BCC's consideration of the Indian Trails Grove rezoning petition.

As you are also aware, on January 30, 2017, the BCC postponed consideration of the lota/Delray LUPA until April 25, 2017. I spoke with Commissioner McKinlay this past week and she again requested the same consideration; that Palm Beach West Associates I, LLLP, request a postponement of the Indian Trails Grove rezoning petition until after final BCC action on the lota/Delray LUPA. We agreed that the June public hearing schedule would be sufficient for that purpose.

Therefore, please consider this letter as our request to postpone consideration of the above zoning petition to the June 1, 2017, ZC and June 22, 2017 BCC public hearings.

Be advised this request does not include a request to postpone the ULDC text amendments PIA 2015-01473 – Western Communities Residential Overlay – scheduled for First Reading on February 23, 2017.
