Palm Beach County Ordinance 2003 - 012 states that a \$50 per page fee shall be assessed for excess plan review, defined as re-submittal after the second critique on the same item.

Florida Statute 553.80.2(b) states that a local government shall impose a <u>fee of four times</u> the plans review portion of the permit fee, <u>each time</u> after the third review, said plan review fee being 1/3 of the Primary fees, where design documents are rejected for failure to correct a code violation specifically and continuously noted in each rejection.
