Donation Boxes – BCC Direction

In February of this year, Goodwill Industries sent a letter to you, and subsequently at the March 6, BCC meeting, staff was directed to look at what Goodwill was requesting and bring back a code amendment. Before staff spends a great deal of time on this issue, we are asking for direction from the Board.

Goodwill is requesting that only "Attended Donation Centers" (ADC) be allowed. From the information that staff has been able to gather, and with input from Goodwill, it appears that Goodwill and maybe one or two other non profit organizations actually provide ADC's. All other for profit or not for profit donation boxes are unattended. Donation Boxes/Station Presentation.

If the BCC were to direct staff to permit only ADC's, all other donation boxes would have to be removed, and would not be allowed. In order to collect shoes, clothes, household goods, etc. a group would be required to provide a structure with appropriate zoning and building approvals and provide an attendant for any period of time that the center is open.

If the BCC were to determine that Unattended Donation boxes are to continue to be allowed, but perhaps better identified, staff would amend the code to put in provisions for additional appropriate safeguards .

In either case, staff will schedule this into the ULDC amendment round 2012-02.

This will be on the April 26 Zoning agenda for discussion and direction.
