### INDUSTRIAL USES UPDATE

On August 20, 2013, the Land Development Regulation Advisory Board (LDRAB) Use Regulations Project Subcommittee convened to review proposed amendments to Industrial Uses. Zoning staff presented 17 Industrial Uses, highlighting changes to definitions, approval processes, supplemental use standards, as well as standards that are being relocated and consolidated in Article 5, Supplementary Standards.

The Subcommittee discussed the proposed amendments and invited participants to ask questions, provide feedback or otherwise advise staff of possible issues. The Subcommittee completed the review of the proposed amendments and recommended minor revisions to Recycling Plant, Towing and Service Storage, and Warehouse Uses, and for Outdoor Activities and Hours of Operation regulations in Article 5.

Amendments to Industrial Uses will be presented at the October 23, 2013 LDRAB meeting. Staff advised that further analysis of recommendations on changes to Article 5 would be initiated, and would be brought back to the next Subcommittee meeting for further review and discussion.

The August 28, 2013 Subcommittee meeting was canceled due to all topics being discussed and addressed during the August 20, 2013 meeting.

At the August 23, 2013 Development Review Advisory Committee (DRAC) meeting, Zoning staff provided an update on the Industrial Uses discussed at the LDRAB Subcommittee meeting. In addition to participating in the Subcommittee meetings, the Zoning Director, Jon MacGillis, invited DRAC members to review the consolidated Use Matrix and provide feedback. He also promoted participation on the Project's survey.

Staff will be updating the BCC on the status of Industrial Use amendments at the September 26, 2013 BCC Zoning Hearing under the Zoning Director Comments portion of the agenda.

## RECREATION USES STATUS

Zoning staff are currently reviewing Recreational Uses, which includes research and analysis of current provisions, industry trends, comparison with other similar jurisdictions, coordination with government agencies, and feedback provided through the Public Survey, among other factors. The Planning and Zoning Divisions are collaborating to verify that any proposed revisions or existing language retained is consistent with the Comprehensive Plan. The Parks and Recreation Department has also been involved. Staff have initiated discussions to ensure that regulations applicable to public parks do not conflict with existing standards established by their department.

It is anticipated that the LDRAB Subcommittee meetings to review Recreational Uses will be scheduled in November. ## RESIDENTIAL USES STATUS

The Zoning Division is preparing to open the Public Survey site for Residential Uses. This survey corresponds to the next use classification to be reviewed as listed in the timeline of the Project.

Zoning staff encourages all interested parties to participate and provide feedback on Residential Uses for:

- Definitions and standards contained in Article 4, Use Regulations; and,
- Approval processes contained in the Use Matrices of Article 3, Overlays and Zoning Districts, and Article 4, Use Regulations.

The survey is expected to open in late October. #### **Uses:**

- 1. Simplify Use definitions.
- 2. Review Supplementary Use Standards.
- 3. Review approval process for each Use.
- 4. Thresholds for approval of Uses.

#### Formatting:

- Consolidate Use matrices (Standard, Planned Development District (PDD), and Traditional Development District (TDD), into one Use Matrix.
- 2. Consolidate Uses by classification.
- 3. Standardize formatting of Supplementary Standards for each Use.


