We, the undersigned, are committed to restoring and protecting Florida's water resources. We are strong supporters of Everglades restoration including the Comprehensive Everglades Restoration Plan (CERP), Restoration Strategies, the Northern Everglades and Estuaries Protection Plans, the dispersed water management program, and the Central Everglades Planning Project.

Part of CERP, the Lake Okeechobee Watershed Restoration Project, is a joint effort of the U.S. Army Corps of Engineers and the South Florida Water Management District. The project will achieve the CERP goal of 80 percent reduction in discharge events from Lake Okeechobee to the coastal estuaries, when combined with the Central Everglades Planning Project.

We urge the Governing Board of the South Florida Water Management District to approve the Lake Okeechobee Watershed Restoration Project so it can be included in the Water Resources Development Act (WRDA) of 2020. Federal authorization in WRDA 2020 will allow Florida to receive cost share credit for their investments in the Lake Okeechobee Watershed Restoration Project components that can be expeditiously built on existing District lands.

Thank you in advance for your consideration. Implementation of Lake Okeechobee Watershed Restoration Project will result in significant additional reductions in the harmful freshwater discharges from Lake Okeechobee to the coastal estuaries.
