Q1.	What changes were included in Amendments 1 and 2 to the VSS solicitation?	3/7/2022
A1.	Amendment 1 to the VSS solicitation was necessary to post and reposition the NOFO Information Guidance attachment to the header section of the VSS system. There were no changes to the NOFO Information Guidance attachment associated with Amendment 1. Amendment 2 to the VSS solicitation was necessary to remove the duplicate posting of the NOFO Information Guidance attachment from the Publishing section of the VSS system. There were no changes to the NOFO Information Guidance attachment associated with Amendment 2.

Q6	Will the text be misaligned when pasted into the portal if pasted from RTF not WORD?	3/10/2022
A6	The text will be misaligned when copied and pasted into the portal. A suggestion is to take information from Word, put it into Notepad, then take it from the Notepad and put it into the browser. Notepad has a feature that will allow you to make formatting corrections. Rich text can be an issue which is why we have chosen plain text, also it allows us to control the printed format. You may preview your proposal before submitting and correct any misalignments before submitting.	
Q7	If the text is misaligned when we copy/paste into the portal do you prefer we do not copy/paste?	3/10/2022
A7	The text will be misaligned when copied and pasted into the portal. A suggestion is to take information from Word, put it into Notepad, then take it from the Notepad and put it into the browser. Q16	The attachments listed in the NOFO are PDF, can we obtain the Excel formats somewhere?	3/10/2022
A16	The NOFO has PDFs; however, when you are completing the application, the excel spreadsheets will be available in the portal.	
Q17	Will you please clarify whether the 15% admin limit applies to the amount of the grant request that is on the admin line, or to the TOTAL organization budget?	3/10/2022

Q18	Is IRS form 990-N acceptable?	3/10/2022
A18	Yes, typically any of the IRS form 990's are acceptable.	
Q19	If the budget submitted is for 1 year, will the next two years have funding to cover staff salary increase due to annual performance increases?	3/10/2022
A19	Agencies have to take such increases into consideration when determining the unit cost. We keep the same negotiated unit cost throughout the contract period. Once we have that determined we do not track any increases. You want to make sure that any increases are built into the unit costs.

Q20	If my organization is not currently a PBC vendor, do we need to become a vendor prior to going through the NOFO process?	3/10/2022
A20	You do not have to be a county vendor to access and enter your proposal as a guest. If you are awarded a contract, you will need to register as a vendor. There is no cost to become a registered vendor.	
Q21	Is the NOFO open to elementary schools also?	3/10/2022
A21	NOFO is open to any not for profit or government agency. If it is a public elementary school, it falls into the category of government agency. However all of the requirements for submission would come from the district level.	
Q22	If you start a NOFO by adding a new proposal can you delete it?	3/10/2022
A22	You can leave it and it will eventually be deleted. Anything incomplete will be deleted later and will not be considered.	
Q23	If the agency is not accredited by Nonprofits First, is there a requirement for an internal audit from an outside firm.	3/10/2022
A23	Yes.	
Q24	I see strategy one specifies "teens". Are the other strategies focused on a particular age group?	3/10/2022
A24	The age group is 0-22 for anything being proposed under this NOFO. There may be certain strategies proposed that may refer to a particular age group and that is up to you.

A25	No, you can not enter nor create tables.

A27 To be eligible to submit a proposal, proposers must attend the Mandatory Pre-Proposal Conference. The Conference was held virtually via Zoom on Thursday, March 10, 2022 at 9:00 a.m. A recording of the mandatory Pre-Proposal Conference is available for review on the YSD website under a tab titled "Notice of Funding Opportunity" at www.pbcgov.com/youthservices/Pages/NOFO.aspx and viewing of the entire recording of the Pre-Proposal Conference shall be considered attendance. At the time of submitting a proposal, each proposer will be required to attest to having either participated in the entire live Zoom Pre-Proposal Conference or viewed the entire recording of the mandatory Pre-Proposal Conference, as explained under Section VI. 2 of the NOFO Information Guidance.	
Q28 Is this something we need to apply for as an agency? Our Award Letter says we're funded until 2024 for our Time for Your Teen program.	3/15/2022
A28 For any agency with a current contract that expires after September 30, 2022, no action in response to this NOFO is required to maintain the funding.	
Q29 Where in the NOFO documents can we find the specifics for budgeting line items - what is and is not allowable for reimbursement. Are there fiscal guidelines? We are trying to prepare the proposed budget for our response to the Youth Services NOFO.	3/16/2022
A29 The NOFO Information Guidance document includes section 3.7 "Budget" as well as Attachment 5 "Program Budget Guidelines". Your program budget should include those salary and operating costs that support your calculated unit rate of service included with your proposal.	
Q30 In 3.7.1, ensure administration expenses are limited to no more than 15%. The next bullet point refers to "indirect/administrative expenses". Are these the same thing and, What is "an approved cost plan from a cognizant agency must be included mean"?	3/16/2022
A30 Yes, these are the same thing. If your agency has an approved indirect cost plan from a cognizant agency, and a single percentage rate is being charged to the entire grant request, then you must include that approved cost plan with your proposal. However, if you are requesting indirect costs and those costs are clearly described within the related line items in your budget worksheet, under the Administrative Expenses section, then an approved cost plan will not be required.	
Q31 I am the owner of Soul Movement. We are a dance studio that provides classes in Ballet, Tap, Jazz, Hip Hop, and Modern. Our goal is to enrich our community through the art of dance. If possible, can I schedule a quick phone meeting to gain further information regarding the requirement of the funding opportunity and the next steps? - A31** Except during the mandatory Pre-Proposal Conference, any explanations/clarifications desired by Proposers must be requested in writing and emailed to the Contact Person no later than the date specified in the NOFO Timeline (Section III). The questions or comments must contain the Proposer's name, address, phone number and email address. All requested explanations, responses, or clarifications, including those posed at the mandatory Pre-Proposal Conference, will be posted on the YSD website under a tab titled "Notice of Funding Opportunity" at www.pbcgov.com/youthservices/Pages/NOFO.aspx. Thus, The NOFO is available on the County's on-line Vendor Self Service (VSS) system at <https://pbcvssp.co.palm-beach.fl.us/webapp/vssp/AltSelfService>. Registered agencies can sign in, or proposers may choose Public Access.
- Q32** **Unfortunately, the FFA only has Mac computers and has written the grant in Microsoft for Mac. I transferred the word doc to a PC and converted the doc to Notepad. However, the document is not showing the corrected Notepad format in the preview. I am not sure the Mac is the actual issue. I even converted the entire document to TXT and PDF. Any suggestions would be appreciated.** 3/19/2022
- A32** A suggestion is to take information from Word, put it into Notepad, then take it from the Notepad and put it into the browser. Submit a proposal by completing all fields in the on-line YSD NOFO Dashboard and uploading all required documents where specified and in the stated file format and file name. Ensure the browser used is Chrome.
- Q33** **Are we able to repeat evidence-based or promising practice programs when selecting outcomes? For example, if we selected number 1 "Youth will benefit physically by participating in structured indoor and outdoor exercise as evidenced by pre-post assessment" twice could we? We would like to provide structured indoor physical exercise (fitness) and collect data via pre/post assessments AND provide structured outdoor exercises (in aquatics) and collect data via pre/post assessments, but make them two separate goals and outcomes. - A33** The on-line NOFO Dashboard (portal) is designed such that a specific outcome can not be repeated (selected more than once) within a proposal application. Additionally, each outcome is fixed as a standard outcome and can not be made as two separate goals and outcomes.
- Q34** **When we go to type information in each section of the NOFO, there does not appear to be a character or word count limit. Are we seeing this correctly? Is there a character or word count associated with each section/question of the NOFO?** 3/21/2022

A36	The administrative expense should either be a percentage approved by a cognizant agency with an approved cost plan or be included in your proposed line item budget. Attachment 5 to the NOFO Information Guidance provides a sample.	
Q37	For the CBA Community Based Agency columns in the budget does this relate to CBA's funding the same services in Palm Beach County only or is it a broader net including any CBA's for any funded services regardless of service or county?	3/22/2022
A37	The program budget template includes columns titled "CBA Program Funder#". These columns are made available if your proposed program will be funded by more than your request to the County. The Program Budget Guidelines (Attachment 5, Item 2) explains this is where a program with multiple funders will complete each column for each funder in detail by line item, as applicable to your program. Your proposal should be for one program for services within Palm Beach County.	
Q38	The wording in the Portal for #3.3.3 and #3.4.1 seems inconsistent from the NOFO Information Guidance.	3/22/2022
A38	For this proposal, choose at least one and no more than four outcomes within the chosen Action Area. For any inconsistencies, Proposers should refer to and rely on the NOFO Information Guidance for correct verbiage.	
Q39	The Logic Model - Could indicator and outcome column need to be switched? Your sample logic model on page 39 states that the indicator is # or percentage of client who achieves outcomes.	
A39	The County's Information System Services Department (ISS) has addressed the request and proposers can log in and see the update which reflects outcomes selected in column 3 of the logic model document.	
Q40	I am unable to access the portal. When I click on the link, it goes to my email. I have tried to reset my password but it doesn't allow me to do that.

- 3) The logic model is created within the portal. Ensure you select an action area and outcomes within the proposal tab. The outcomes will pre-populate in column 3 of the logic model.
