

## Community Based Agencies FY 2023 Recommended Funding

May 4, 2022

These funding recommendations are subject to Board of County Commissioners' approval and successful contract negotiations. Funding recommendations are currently scheduled to be presented to the Board of County Commissioners for approval at their meeting on June 14, 2022. As a reminder, the Cone of Silence remains in place.

"Cone of Silence" means a prohibition on any non-written communication regarding this NOFO between any Proposer or Proposer's representative and any County Commissioner or Commissioner's staff. A Proposer's representative shall include, but not be limited to, the Proposer's employee, partner, officer, director or consultant, lobbyist, or any, actual or potential subcontractor or consultant of the Proposer."

## **Right of Appeal/Protest**

Any Proposer may protest a recommendation for contract award by submitting a written protest to the Director, Youth Services Department within five (5) business days of the posting of the Recommended Contract Awards. The protest shall be submitted in writing, shall identify the protestor and the solicitation, shall include a factual summary of the basis for the protest, and shall be addressed to the Director, Youth Services Department, via hand-delivery or mail to 50 S. Military Trail, Suite 203, West Palm Beach, FL 33415, or via email to <a href="mailto:tfields@pbcqov.org">tfields@pbcqov.org</a> and reference in the subject line: NOFO FY 2023 Protest. A protest is considered filed when it is received by the Director, Youth Services Department. Failure to file a protest within five (5) business days of the posting of the Recommended Contract Awards shall constitute a waiver of the Proposer's right to protest.
